

## DEVON COUNTY COUNCIL

*The County of Devon (Various Streets Crediton)  
(Prohibition of Waiting) Order 1976*

Notice is hereby given that on the 25th January 1977, the Devon County Council made the above written Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967 as amended. The effect of this Order which will come into force on the 31st January 1977 is that some lengths of the following roads will be subject to waiting restrictions: Church Lane, Church Street, Exeter Road (A.377) and Mill Street.

Full details and a plan showing exactly how these roads will be affected may be seen during usual office hours at the Tiverton District Council Offices, Market Street, Crediton and at Room 3.33 Civic Centre, Exeter.

If you wish to question the validity of the Order or anything contained in it on the grounds that it is not within the powers conferred by the above Act or on the grounds that any requirement of the above sections or any regulations thereunder have not been complied with in relation to the Order, you may within 6 weeks from the 25th January 1977 apply to the High Court for this purpose.

## DEVON COUNTY COUNCIL

*The Devon County Council (Fair View, Pilton Quay and Pilton Street, Barnstaple) (Traffic Regulation) Order 1977*

Notice is hereby given that on 24th January 1977 the Devon County Council made an Order under sections 1 and 84 of the Road Traffic Regulation Act 1967, as amended.

The effect of the Order, which comes into operation on 21st February 1977, is to prohibit vehicles from waiting, at all times, in Pilton Quay and specified lengths of Pilton Street and Fair View.

There are exceptions in the Order to permit waiting for the purposes of: picking up and setting down of passengers; loading and unloading goods; collecting and delivering postal packets for the Post Office; and where necessary, in connection with the maintenance of the road, and the supply of gas, electricity and water. An exception relating to disabled persons vehicles is also included.

A copy of the Order and a map showing the lengths of roads concerned may be examined during normal office hours, Monday to Friday, at Room 304, Civic Centre, Barnstaple.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 24th January 1977, apply to the High Court for this purpose.

## DONCASTER BOROUGH COUNCIL

*The Doncaster Borough Council (County Borough of Doncaster) (Off Street Parking Places) Order 1967 (Amendment) Order 1977.*

Notice is hereby given that the Doncaster Borough Council propose to make an Order under sections 31 (1) and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972, amending the County Borough of Doncaster (Off Street Parking Places) Order 1967 by increasing the scale of charges at the Council's Multi-Storey Car Parks at Cleveland Street Roundabout and North Bridge, Doncaster to 20p per exit, and £20 per quarter.

## ESSEX COUNTY COUNCIL

*The Essex County Council (Various Streets, Thaxted) (Restriction of Waiting) Order 1977*

Notice is hereby given that the Essex County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended.

The effect of the Order, will be to impose the following additional waiting restrictions at Thaxted:

*Waiting prohibited between 9 a.m. and 6 p.m., each day*

*Margaret Street*

North-west side—from its junction with Vicarage Close north-eastwards to its junction with Guelphs Lane a distance of approximately 200 metres (219 yards).

South-east side—from its junction with Vicarage Close north-eastwards to its junction with Weaverhead Lane a distance of approximately 190 metres (208 yards).

*Guelphs Lane*

South-west side—from its junction with Margaret Street north-westwards for a distance of 13.6 metres (15 yards).

*Weaverhead Lane*

South-west side—from its junction with Margaret Street south-eastwards for a distance of 13.6 metres (15 yards).

*Vicarage Close*

Both sides—from its junction with Margaret Street north-westwards for a distance of 13.6 metres (15 yards).

Exceptions in the Order permit waiting for the purpose of:

- (a) picking up or setting down passengers,
- (b) loading or unloading goods

and, where necessary, in connection with:

- (c) the maintenance of the road,
- (d) the supply of gas, electricity and water, and
- (e) the maintenance of Post Office services.

A copy of the Order together with a map illustrating the proposal in question, and a statement of the Council's reasons for making the Order may be examined during normal office hours at:

## HALTON BOROUGH COUNCIL

*The Halton Borough Council (Devonshire Place and Regent Street (Part) Runcorn) (Revocation and Prohibition of Waiting) Order 1977.*

Notice is hereby given that the Halton Borough Council as agents for the Cheshire County Council propose to make an Order under sections 1 and 84D (1) of the Road Traffic Regulation Act 1967, as amended, the effect of which would be:

- (a) to revoke The Runcorn Urban District Council (Devonshire Square) (Unilateral Prohibition of Waiting) Order 1962 and The Runcorn Urban District Council (Regent Street) (Unilateral Prohibition of Waiting) Order 1961 insofar as it relates to that length of Regent Street which extends from Devonshire Place to a point 6 metres north of its junction with Cross Street; and
- (b) to prohibit the waiting of vehicles at all times in the lengths of road specified in the Schedule to this Notice.

The Order would contain the usual exemptions to the prohibition of waiting outlined in (b) above for the purposes of boarding or alighting, loading and unloading, maintenance of essential services, building and road works, the
