The Order also makes various regula-tions for the use of the parking places. Charges are to be made for parking, details of which are given in Schedule 2 to the advantage. Initially the charges will be as set out in Part I of Schedule 2 but the Council may in future increase the charges to amounts not exceeding those set out in Part II. An excess charge of £3 will be made if a vehicle is parked

An excess charge of 2.3 will be made if a venicle is parked for a longer time than that which has been paid for. Other goods vehicles if specific-ally indicated by notice displayed on the parking place and in relation to the parking place mentioned in (k) above other goods vehicles parked in connection with a function in the Benn Memorial Hall.

Days of Operation of parking place—All days unless specifically indicated by notice displayed on the parking place.

Hours of Operation-All hours unless specifically indicated by notice displayed on the parking place.

Maximum period for which vehicles may park-24 hours.

- (c) Goods ventues of an unader weight exceeding 5 tons (where permitted): 10p for 1 hour, 20p for 5 hours, 30p over 5 hours.
  (d) Season tickets (where applicable) for a period of 3 months for motor cars, etc.: £8 plus VAT.

The above charges to be made between the hours of 8 a.m. and 6 p.m. Mondays to Saturdays.

### Part II. Maximum Charges

(Charges may be increased in future to amounts not exceeding those set out below.)

Notice is hereby given that on the 21st January 1977, the Notice is hereby given that on the 21st January 1977, the Somerset County Council made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended, the effect of which is to prohibit any vehicle the weight of which whether laden or unladen exceeds three tons from proceeding in Church Lane (Class III) Road in the parishes of Shepton Mallet and Pilton in the district of Mend'p between its northern junction with route A.37 at Cannards Grave and its southern

junction with route A.37 at Beardly Batch. The Order will come into operation on the 31st January 1977.

Exemptions are made in the Order for access to premises for the maintenance of the road and services therein and in respect of vehicles belonging to a local authority or statutory undertaker summoned by an emergency call.

Notice is hereby given that on 25th January 1977 Suffolk County Council made an Order the effect of which is to continue in force until 30th July 1977 the Suffolk County Council (Parishes of Leavenheath, Polstead and Stoke-by-Nayland) (B.1068 Road) (Prohibition of Commercial Vehicles of over 3 tons) (Experimental) Order 1976. The effect of the original Order is to prohibit the use of the length of road described in the Schedule to this notice by heavy commercial vehicles exceeding 3 tons un-laden weight unless a vehicle is being used for the con-

laden weight unless a vehicle is being used for the con-veyance of goods to or from any premises situated on or adjacent to that length of road, for purposes of agriculture on any land adjacent to that length of road or other certain purposes specified in the Order. The prohibition does not apply to public service vehicles, school buses and work buses.
