### KENSINGTON AND CHELSEA ROYAL BOROUGH COUNCIL

ROAD TRAFFIC REGULATION ACT 1968 Controlled Parking Zones Amendments

Notice is hereby given that the Council of the Royal Borough of Kensington and Chelsea are applying to the Greater London Council for an Order entitled "The Kensington and Chelsea (Parking Places) (1968) (Amendment No. ) Order 197", under sections 35, 36, 37, 40 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968.

2. The general effect of the Order would be, in the Royal

Borough of Kensington and Chelsea:

(a) to amend the existing rate of charge made for the leaving of vehicles in the metered parking places designated by the Kensington and Chelsea (Parking Places) Order 1968, or in any metered parking place to which the provisions of that Order have been applied on the highways referred to in Schedules 1 to 6 of this notice so that the charge would be at the rate of:

(i) five new pence for a period of thirty minutes (maximum two hours) in the parking places on the highways referred to in Schedule 1; or

(ii) ten new pence for a period of one hour (maximum two hours)

(ii) ten new pence for a period of one hour (maximum four hours) in the parking places on the highways referred to in Schedule 2; or

(ii) five new pence for a period of twenty minutes (maximum two hours) in the parking places on the highways referred to in Schedule 3; or

(iv) ten new pence for a period of forty minutes (maximum four hours) in the parking places on the highways referred to in Schedule 4; or

(v) five new pence for a period of fifteen minutes (maximum two hours) in the parking places on the highways referred to in Schedule 5: or

(vi) ten new pence for a period of thirty minutes (maximum four hours) in the parking places on the highways referred to in Schedule 6.

(b) to provide that coins of the denomination of five new pence may be used for the payment of the revised charges in the parking places referred to in Schedule or 3; of ten new pence in parking places referred to in Schedule 2, 4 or 6; and of five new pence or of ten new pence in the parking places referred to in Schedule 5.

- (c) to increase the charge payable in respect of a vehicle left in a parking place during the permitted hours for longer than the period for which payment was made by the initial charge to three pounds (the "excess charge") in the parking places on the highways referred to in Schedule 3 and 4 and to four pounds (the "excess charge ") in the parking places on the highways referred to in Schedules 5 and 6.
- (d) in respect of all the parking places on the highways referred to in the Schedules, the period for which a vehicle may be left in a parking place after the excess charge has been incurred would be one hour.
- 3. The classes of vehicles for which the parking places would be available, the "permitted hours" for parking, and except as provided above, all the other time limits
- and charges would remain unchanged.

  4.
