## PUBLIC PATH DIVERSION ORDER 1977

Notice is hereby given that the above named Order (hereinafter referred to as "the Order") made on the 27th January 1977 is about to be submitted to the Secretary of State for Wales for confirmation or to be confirmed by the South Glamorgan County Council as an unopposed Order.

The effect of the Order, if confirmed without modifications, will be to divert the public right of way running across land situate at Barry and more particularly described in the Schedule annexed hereto.

A copy of the Order and a map contained in it has been deposited at the offices of the County Solicitor at the address below and at the Information Office, Vale of Glamorgan Borough Council, Town Hall, Barry, and may be inspected free of charge during normal office hours.

Any representation or objection with respect to the Order may be sent in writing to the County Solicitor, at the address below not later than the 3rd March 1977 and should state the grounds on which it is made.

If no representations or objections are duly made, or if any so made are withdrawn, the South Glamorgan County Council may instead of submitting the Order to the Secretary of State for Wales for confirmation, itself confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

## SCHEDULE

## PART I

*Description of site of existing path*

The footpath to be diverted is in the Barry area of the Vale of Glamorgan in the County of South Glamorgan, namely:

That length of footpath No. 20 commencing at point "A" approximately 12 metres north of the end of the lane between properties No. 36 and 38 Collard Crescent and running in a south-easterly direction for approximately 150 metres and then in a southerly direction for approximately 100 metres to point "B" near the south-east boundary of property No. 2 Collard Crescent.

## PART II

*Description of site of alternative highway*

That part of footpath commencing at point "A" and running in a southerly direction for approximately 40 metres to and along the lane between properties Nos. 36 and 38 Collard Crescent to Collard Crescent, along the northern surfaced footway of Collard Crescent for approximately 225 metres to point "B".

## HAVERING LONDON BOROUGH COUNCIL

*The London Borough of Havering (Footpath 110 Romford) Public Path Diversion Order 1977*

Notice is hereby given that the above named Order (hereinafter referred to as "the Order") made on the 21st January 1977 is about to be submitted to the Secretary of State for the Environment for confirmation or to be confirmed by the Council of the London Borough of Havering as an unopposed Order.

The effect of the Order if confirmed without modification will be to divert that part of footpath 110 between Brooklands Lane and Brooklands Close which extends in an westerly direction for a distance of about 52 metres. The purpose of the diversion is to enable the carrying out of a scheme for improvement to a section of the River Rom for the prevention of flooding. A new section of footpath is being provided as part of that scheme.

A copy of this Order and the map contained in it has been deposited at the Town Hall, Main Road, Romford

and may be inspected free of charge between the hours of 9.30 a.m. and 4 p.m. Monday to Friday.

Any representations or objections with respect to the Order may be sent in writing to the Borough Secretary, Town Hall, Romford, RM1 3BD not later than 11th March 1977 and should state the grounds on which it is made.

If no representations or objections are duly made or if any so made are withdrawn, the Council may instead of submitting the Order for confirmation, themselves confirm the Order as an unopposed Order. If the Order is submitted to the Secretary of State for confirmation any representations and objections which have been duly made and not withdrawn will be sent to the Secretary of State with the Order.

## LEOMINSTER DISTRICT COUNCIL

## TOWN AND COUNTRY AMENITIES ACT, 1974

Notice is hereby given that the Leominster District Council in pursuance of their powers under section 277 (1) of the Town and Country Planning Act 1971 have designated the undermentioned area of the District as a Conservation Area.

*Weobley.* The Conservation Area consists of all the village and certain surrounding fields. The boundary at the north runs along the A.4112 to its junction with the B.4230, and at the south runs just south of the site of Garnstone Castle. On the east and west it runs at least two fields' depth from any development and is shown by a broken black line on the map marked "Weobley Conservation Area Map".

The map showing this area can be inspected during normal office hours at Leominster District Council Planning Department.

The effect of this designation will be that no person may, without the written consent of the Council demolish any building within the conservation area, nor cut down, top, lop, uproot, wilfully damage or wilfully destroy any trees without giving to the Council 6 weeks notice. Offences against these provisions may result in heavy fines. The Council will also give special attention to the desirability of preserving or enhancing the character or appearance of the Conservation Area.

## NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

*The Mendip District Council (Leigh-on-Mendip 8/14) Public Path Stopping-up Order 1976*

Notice is hereby given that on 18th January 1977 the Mendip District Council confirmed the above-named Order.

The effect of the Order, as confirmed, is to stop-up the public footpath 8/14 at Leigh-on-Mendip which runs from point A south-east for some 46 metres to point B where it turns and runs in an east-south-easterly direction for some 210 metres to point C then in a south-easterly direction for some 164 metres to point D where it turns to the north-east for 130 metres to point E all referred to and more clearly indicated on the map contained in the Order.

A copy of the confirmed Order and map contained therein has been deposited at and may be inspected free of charge at the Council Offices, Wookey Hole Road, Wells between 9 a.m. and 4 p.m. on Mondays to Fridays inclusive.

The Order becomes operative from 18th January 1977 but if any person aggrieved by the Order desires to question the validity thereof or of any provision contained therein on the grounds that it is not within the powers of the Town
