that burials should be discontinued as hereinafter directed in Englishcombe Churchyard, Englishcombe, in the County of Avon, shown hatched on the plan annexed hereto, has in Pursuance of an Order in Council made the 15th day of November 1976, and duly published, been taken into consideration by a Committee of the Privy Council:

Now, therefore, Her Majesty Queen Elizabeth The Queen Mother and His Royal Highness The Prince Charles, Prince of Wales, being authorised thereto by the said Letters Patent, and in exercise of the powers conferred on Her Majesty by section 1 of the Burial Act 1853 (1853 c. 134) and of all other powers in that behalf, do hereby, by and with the advice of Her Majesty's Privy Council, on Her Majesty's behalf order, and it is hereby ordered, as follows:


1. Burials shall be discontinued forthwith in Englishcombe Churchyard, Englishcombe, in the County of Avon, shown hatched on the plan annexed hereto.

Provided that in any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretofore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds (Englishcombe Churchyard, Englishcombe, Avon) Order 1977.
