TYNE AND WEAR COUNTY COUNCIL

 - Naylor Street, Miles Platting—the north-east side from Mellor Street to the cul de sac end, including the turning head.
 - Elizabeth Slinger Road, Withington—both sides from its junction with Nell Lane for a distance of 15 metres in a southerly direction.

The proposed Orders contain exceptions to permit waiting for the purposes of boarding or alighting, loading or unloading, the removal of furniture, funerals, building operations or work on or under the lengths of road or to take in petrol, oil, water or air from any garage on or adjacent to the lengths of road, except that the loading or unloading of vehicles will be prohibited from 8 a.m. to 9.30 a.m. on Mondays to Saturdays and from 4 p.m. to 6 p.m. on Mondays to Fridays on Burnage Lane, Crossley Road and Grangethorpe Drive, Burnage.

Disabled persons vehicles displaying the relevant disabled person's badge will be allowed to wait for up to two hours, return prohibited within one hour.

(B) to prohibit vehicles entering or leaving:

- (i) the passage adjacent to numbers 8 and 10 Chataway Road, Crumpsall.
- (ii) the passages between numbers 16 and 18 Whiteway Street and between numbers 32 and 34 Whiteway Street, at their junctions with Whiteway Street, Moston.
- (iii) the passage adjacent to number 89 Rylance Street at its junction with Rylance Street, Beswick.

(iv) Debdale Avenue, Gorton at its junction with Hyde Road.

(C) to continue the following streets in use as play streets, by prohibiting vehicular traffic from 8 a.m. to sunset daily:

Faraday Avenue, Cheetham Hill.
Galsworthy Avenue, Cheetham Hill.

The proposed Order contains exceptions to permit entry for the conveyance of persons or goods to any premises on or adjacent to the roads and for building operations or work on or under the lengths of road.

(D) to prohibit cycling on the passage at the rear of Purslow Close, Beswick, running from Ashton New Road to Viaduct Street.

(E) to prohibit the driving of vehicles in the passageway adjacent to 53 Lawson Street, Blackley, from a point 19 metres south of the southerly kerb line of Lawson Street for a distance of 3 metres in a southerly direction.

Fareham Borough Council (Town Centre, Fareham)
(Traffic Regulation No. 1) Order 1977

Notice is hereby given that Fareham Borough Council made an Order on 18th February 1977 pursuant to arrangements made under Section 101 of the Local Government Act 1972 with Hampshire County Council in exercise of the powers of the said County Council under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974.

The Order which comes into operation on 2nd March 1977 makes it unlawful for any person to cause or permit any vehicle to proceed at any time in that section of West Street between its junction with Quay Street and its junction with Portland Street. Exemptions to the Order allowing vehicles to proceed east to west only in this section of West Street include:

- (i) goods vehicles being used for the delivery or collection of goods merchandise to the shops and premises situate adjacent to this section of West Street which do not have a rear service or other facility available at the time of delivery;
- (ii) vehicles specifically designed or adapted for the transport of quantities of cash or other items of high value delivering or collecting the same to and from any bank premises situate adjacent this section of West Street;
- (iii) emergency service vehicles;
- (iv) vehicles being used in connection with building operations, demolition or road works, which cannot conveniently be used for such purpose in any other road;
- (v) vehicles being used in connection with a wedding, funeral or other religious service at the United Reformed Church situated in this section of West Street;
- (vi) vehicles being delivered to or collected from Wadham Stringer (Fareham) Limited in connection with the service, repair, purchase or sale of such vehicles;
- (vii) vehicles requiring access to or egress from the shops and premises situate adjacent to this section of West Street between the hours of 5 p.m. and 9 a.m.;
- (viii) vehicles requiring access to or egress from the garages at the rear of "The Crown" Public House;
- (ix) vehicles requiring access to or egress from the garages in Hewlett Court at the rear of 30/32 West Street;
- (x) various classes of invalid vehicles;
