SCHEDULE

Description of Highway to be stopped up (The distances are approximate)

The highway is at Cardiff in the County of South Glamorgan. It is shown by zebra hatching on the deposited plan and is that length of road known as Mill Lane, St. Mellons, which extends from a point 272 yards north-west of its junction with Tyr Winch Road, in a northwesterly direction for a distance of 33 yards.
