**TOWN AND COUNTRY AMENITIES ACT 1974** 

Notice is hereby given that the Cherwell District Council have, pursuant to section 277 of the Town and Country Planning Act 1971, as re-enacted by section 1 of the Town and Amenities Act 1974, designated the area described in the Schedule below as the Drayton Conservation Area. - (d) It is an offence to cut down, top, lop, uproot, wilfully damage or wilfully destroy any tree in a conservation area (and not already the subject of a tree preservation Order), without giving 6 weeks' notice to the District Council. This provision does not relate to trees covered by a felling licence, to dead trees, where the trees concerned do not exceed 75mm (3 inches approximately) in diameter, and in certain other cases details of which can be obtained from the Cherwell District Council.
