The Trunk Road (Broughton, Clwyd) (Prohibition of Waiting) (Clearways) (Wales) Order 1977

Notice is hereby given that the Secretary of State for Wales has made an Order under Section 1 (1), (2), (3) and (6) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, which shall come into operation on 8th March 1977. The effect of the Order is to prohibit waiting at any time in the length of trunk road specified in the Schedule to this Notice, and to prohibit any vehicle waiting on any verge adjacent to the said length of trunk road for the purpose of selling goods from that vehicle, unless the goods are immediately delivered at or taken into premises adjacent to the vehicle from which the sale is effected.

Exceptions are provided in the Order to enable a vehicle to be used in connection with any building operation or demolition, the removal of any obstruction or potential obstruction to traffic, or the maintenance of the road or the services therein; to enable a vehicle to be used for fire brigade, ambulance or police purposes; and to enable a vehicle to wait in any case where the person in control of the vehicle is required by law to stop, is obliged to stop in order to avoid an accident, or is prevented from proceeding by circumstances outside his control.

A copy of the Order, together with plans and a Statement

of Reasons for making the Order, may be seen during normal office hours at the offices of the Clwyd County Council, Shire Hall, Mold CH7 6NB; and at the offices of the Alyn and Deeside District Council, Council Offices, Glynne Way, Hawarden, and Council Offices, Civic Centre, Connahs Quay.

If you wish to question the validity of the Order, or of any provision contained therein, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, or that any requirement of that Act, or of any instrument made under it, has not been complied with in relation to the Order, you may, within six weeks of 24th February 1977 apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

That length of the Chester—Bangor Trunk Road (A55)—Chester Southerly By-Pass at Broughton in the County of Clwyd which extends from its junction with the roundabout which forms part of that trunk road at Broughton in a general easterly direction for a distance of approximately 1,902 yards.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary to enable a person to board or alight; to enable goods to be loaded on or unloaded from a vehicle; to enable a vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in connection with any funeral, wedding, building, industrial or demolition operation, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the said sides of roads, the laying, erection, alteration or repair, in or near the said sides of road or any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity of any telegraphic line as defined in the Telegraph Act, 1878, to enable a vehicle, if it cannot conveniently be used for such purposes in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties; to enable a vehicle if it is in the service of or employed by the Post Office to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953; to enable a vehicle to take in petrol, oil, water or air from any garage situated in or adjacent to any of the said sides of road; to enable a vehicle to be loaded or unloaded while it is in actual use in connection with the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises from a depository. In addition, the restrictions imposed by the Order will not apply to Hackney Carriages while waiting on a duly authorised cab rank vehicles waiting on a duly authorised parking place and disabled persons vehicles will also be permitted to wait for up to two hours.
