Rates of Pay for Continuous Training

3. The rates of pay for continuous training payable to officers and men recruited locally for service with the Headquarters Reserve Unit of the Royal Naval Reserve at Gibraltar shall be as set out in the Schedule to this Order, which shall be substituted for the rates set out in the Schedule to the Naval Reserves (Gibraltar) Pay Order 1971 which were substituted by the Naval Reserves (Gibraltar) Pay (Amendment) Order 1974.

Renocation

4. The Naval Reserves (Gibraltar) Pay (Amendment) Order 1974 is hereby revoked with effect from the date of this Order without prejudice, however, to the validity of anything done thereunder.

Whereas Her Majesty, in pursuance of the Regency Acts 1937 to 1953, was pleased, by Letters Patent dated the 3rd day of February 1977, to delegate to the six Counsellors of State therein named or any two or more of them full power and authority during the period of Her Majesty's absence from the United Kingdom to summon and hold on Her Majesty's behalf Her Privy Council and to signify thereat Her Majesty's approval for anything for which Her Majesty's approval in Council is required:

And whereas it is expedient to provide for revised rates and conditions of award of pensions to the widows and children of deceased Officers, Petty Officers, Non-Commissioned Officers and Men of the Royal Navy and Royal Marines:

Now, therefore, Her Majesty Queen Elizabeth The Queen Mother and His Royal Highness The Prince Charles, Prince of Wales, being authorised thereto by the said Letters Patent, and in pursuance of the powers conferred by section 3 of the Naval and Marine Pay and Pensions Act 1865 (c. 73), and all other powers enabling Her Majesty, and by and with the advice of Her Majesty's Privy Council, do on Her Majesty's behalf order, and it is hereby ordered, as follows:

Citation

1. This Order may be cited as the Naval and Marine Pay and Pensions (Family Pensions) Order 1977.

Interpretation

2. The Interpretation Act 1889 (c. 63) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

General

- 3. The revised rates and conditions of award of widows' and children's pensions in respect of the service of deceased Officers, Petty Officers, Non-Commissioned Officers and Men of the Royal Navy and Royal Marines shall be as specified in the Schedule annexed hereto.
 - 4. Except as otherwise indicated, the provisions of the said Schedule shall have effect from 1st April 1976.

SCHEDULE

SECTION I

- 1. The family pension and other awards provided for in this Schedule are those payable in respect of the service of deceased Officers, Fleet Chief Petty Officers, Chief Petty Officers, Petty Officers, Non-Commissioned Officers and Men of the Royal Navy and the Royal Marines and awards which are payable in respect of deaths which are attributable to service.
- 2. Except where otherwise stated the term "Officers" in this Schedule should be read as including Commissioned Officers of the Royal Navy and of the Royal Marines and "RN rating and RM other rank" should be read as including Fleet Chief Petty Officers, Chief Petty Officers, Petty Officers and other ratings of the Royal Navy and Non-Commissioned Officers and other ranks of the Royal Marines.

SECTION II

General Conditions Governing the Award of Family Pensions

3. If the death of an Officer, RN rating or RM other rank was due wholly or in part to his own negligence or misconduct or to any cause within his own control the award and amount of any family pension payable shall be at the discretion of the Secretary of State for Defence.
