The Trunk Road (High Street, Melbourn) (Prohibition of Waiting) Order, 1977

The Secretary of State for Transport has made an Order

The Secretary of State for Transport has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 on the London-Cambridge-King's Lynn Trunk Road. The effect of the Order, which comes into operation on 14th March 1977, is to prohibit the waiting of vehicles at any time on any day in that length of High Street from a point 114 yards north-east of its junction with Mortlock Street to a point 250 words parth east of that junction Street to a point 250 yards north-east of that junction.

Exceptions have been provided in the Order to enable a vehicle to wait for so long as may be necessary for a period to board or alight from a vehicle, to enable goods to be loaded on to or unloaded from the vehicle, or to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or the services therein, and for a disabled person's vehicle as defined in the Local Authorities' Traffic Orders (Exemptions for Disabled Per-sons) (England and Wales) (Amendment) Regulations 1975, to wait.

Any person who desires to question the validity of, or of any provision contained in, the Order, on the ground that it is not within the powers with respect to the Order con-ferred by the above Act, or on the ground that any requirenent of, or of any instrument made under, any provision of that Act has not been complied with in relation to the Order, may within 6 weeks of the 7th March 1977, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

The Trunk Road (Barton-Le-Clay) (Restriction of Waiting) Order, 1977

The Secretary of State for Transport has made an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 on the London-Glasgow-Inverness Trunk Road.

The effect of the Order, which comes into operation on 21st March 1977, is to revoke and re-enact with an additional length the existing waiting restriction on the A6 Trunk Road at Barton-le-Clay. The additional restriction would prohibit vehicles waiting on the west side of Bedford Road from its junction with Sharpenhoe Road to a point 83 yards north of that junction.
