The North Hertfordshire District Council (Lytton Avenue-Gernon Road, Letchworth) (Experimental Prohibition of Entry) Order 1977

The North Hertfordshire District Council (Lytton Avenue-Gernon Road, Letchworth) (Experimental Restriction of Waiting) Order 1977

Notice is hereby given that the North Hertfordshire District Council acting as agents for the Hertfordshire County Council made two Orders on the 3rd March 1977 under section 9 (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974, directing that the above-named experimental Orders shall continue in force until the 22nd September 1977, or until proposed permanent Orders become operative, whichever date is the earlier.

There is no change in the effect of the Orders, which:

- prohibit any vehicle proceeding in Gernon Road, Letchworth, from entering Lytton Avenue, and prohibit any vehicle proceeding in Lytton Avenue from entering Gernon Road;
- prohibit the parking of vehicles in the lengths of roads specified in the Schedule on any day between the hours of 8 a.m. and 12 midnight (with exemptions for loading and unloading; Post Office, public service and statutory undertakers vehicles; building operations and road maintenance; fire brigade, ambulance or police purposes; and for disabled persons).

A copy of the Orders and a map showing the lengths of roads affected may be inspected at my office between 9 a.m. and 4.30 p.m. Monday to Friday.

Any person who desires to question the validity of the Orders or of any provision contained in them on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1967, as amended or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Orders, may, within 6 weeks of the day the Orders were made, apply to the High Court for this purpose.
