Wincheap

(a) on the south-east side from its junction with Tudor Road for a distance of 66 feet south-westwards.

- (b) on the north-west side from a point 47 feet south-west of the south-west kerbline of Simmonds Road to a point 45 feet south-west of its junction with Gordon Road.
- 3. The exemptions for disabled persons' vehicles shall cease to apply from 8.30 a.m. to 9.30 a.m. and 4.45 p.m. to 6 p.m. on Mondays to Saturdays in those lengths of the following roads which are at present subject to bans on loading and unloading:

Beer Cart Lane, The Borough, Broad Street, Castle Street, Guildhall Street, High Street, Kingsmead Road, Lower Bridge Street, New Dover Road, Northgate, Old Dover Road, Palace Street, Parade, Pin Hill, Rhodaus Town, St. Dunstan's Street, St. George's Place, St. George's Street, St. Margaret's Street, St. Peter's Street, Stour Street, Upper Bridge Street, Watling Street, Whitestable Road Whitstable Road.

Full details of the lengths of the above streets affected by this provision are contained in the Third Schedule to the Canterbury (Prohibition of Waiting) Order 1970.

- 4. The removal of prohibition of waiting at any time on the south-east side of Roper Road between points 128 feet and 1,247 feet north-east of the south-west kerbline of St. Dunstan's Street where a restriction on waiting now applies between 8 a.m. and 6.30 p.m. Mondays to Saturdays by virtue of a previous amendment Order.
- 5. No waiting between 8 a.m. and 6.30 p.m. Mondays to Saturdays (with effect from a date to be announced later) in the following roads:

Reed Avenue, from its junction with South Street to a point level with the north-east building line of 78 Reed Avenue.

South Street

- (a) on the south side from a point 50 feet south-east of the south-east kerbline of Sturry Road to a point 45 feet south-east of the south-east kerbline of Reed Avenue;
- (b) on the north-east side for a distance of 45 feet north-westwards and south-eastwards from its junction with Reed Avenue.

Note. The revisions in Linden Grove and Station Road West in paragraph 2 of this Schedule involve the abolition of all parking places in Linden Grove, and the abolition of parking places in Station Road West between points 168 feet and 220 feet from the north-east kerbline of St. Dunstan's Street.

Otherwise the provisions of existing parking places along the affected lengths of road will remain in force.

5. At the Culver Street (West) Car Park the charge will be 20p for the first 2 hours or lesser period, 30p for more than 2 hours but not exceeding 3 hours and 50p for more than 3 hours but not exceeding 4 hours, the maximum permitted

time. No season tickets will be available.

6. The charges set out in paragraph 5 shall also relate to Culver Street (Library) Car Park except that such car park is not available for use between the hours of 5 a.m. and 7 p.m. on Saturdays or market days for any class of vehicle.

7. At the St. John's Street Car Park and extension, Vine-7.
