Stakes Hill Road

- (a) On the eastern side from its junction with Hurstville Drive northwards for a distance of 120 metres to the boundary of Nos. 63 and 65 Stakes Hill Road; and
- (b) on the eastern side from its junction with Hurstville Drive southwards for a distance of 40 metres.
- (c) On the western side from its junction with Elizabeth Road northwards for a distance of 137 metres to a point opposite the boundary of Nos. 63 and 65 Stakes Hill Road.
- (d) On the western side from its junction with Elizabeth Road southwards for a distance of 21 metres.

Elizabeth Road.

On both sides from its junction with Stakes Hill Road southwards for a distance of 30 metres.

Hurstville Drive

On both sides from its junction with Stakes Hill Road eastwards for a distance of 41 metres.

Beechwood Avenue

On both sides from its junction with Stakes Hill Road westwards for a distance of 9 metres. (817)

Notice is hereby given that on 25th February 1977 the Hertfordshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit any person from causing or permitting any heavy commercial vehicle to proceed in that length of Pig Lane, Thorley from its junction with the A.1060 Hallingbury Road to a point 30 feet west of the railway bridge. Exceptions are provided in the Order for the conveyance of persons, goods or merchandise to or from premises situated on or adjacent to the length of road and Twyford Bury Lane and for the purposes of agriculture, building operations and road maintenance, services in connection with statutory undertakings and emergency services in connection with statutory undertakings and emergency services. HERTFORDSHIRE COUNTY COUNCIL

The County of Hertford (Whitehorse Street, Baldock) (Prohibition and Restriction of Waiting) Order 1977

Notice is hereby given that on the 25th February 1977 the Hertfordshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the

effect of which is to prohibit and restrict the waiting of vehicles in Whitehorse Street, Baldock as follows:

South side—Restriction of waiting of 1 hour in any 2 hours with return prohibited within 1 hour from 9 a.m. to 6 p.m. on all days from a point 177 feet north-east of its junction with High Street north-eastwards for a distance of 290 feet.

South side. Restriction of waiting of one hour in any two hours with return prohibited within one hour from 9 a.m. until 6 p.m. on all days from a point 467 feet north-east of its junction with High Street for a distance of 95 feet to a point 210 feet south-west of its junction with Clothall Road.

The Order contains exemptions to permit waiting for the purposes of boarding or alighting, loading or unloading. Disabled persons vehicles displaying a disabled persons badge and a parking disc will be allowed to wait up to 2 hours, with a return prohibited in 1 hour.

HERTFORDSHIRE COUNTY COUNCIL

The County of Hertford (High Street, Hoddesdon) (Restriction of Waiting) Order 1977

Notice is hereby given that the Hertfordshire County Council propose to make an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which will be to restrict the waiting of vehicles as follows:

High Street, Hoddesdon (eastern side) Limited waiting of one hour in any two hours, with return prohibited in one hour, from 9 a.m. until 6 p.m. Mondays to Saturdays inclusive, for a distance of 18 yards northwards from the centre line of Brocket Road and 42 yards southwards from the same point.

Waiting by vehicles of the undermentioned classes or for the following purposes will be exempted from the provisions of the Order:

1. To enable persons to board or alight.
2. To enable goods to be loaded or unloaded.
3. Vehicles in use by the Post Office or for fire, ambulance or police purposes.
4. To enable certain essential works to be carried out or in pursuance of statutory powers or duties.
5. Disabled persons displaying a badge issued under the Local Authorities Orange Badge Scheme.

A copy of the draft Order and a map showing the road affected, together with a statement of reasons for the proposed Order may be inspected at the offices of the Broxbourne Borough Council, High Street, Hoddesdon, or the Manor House, Turners Hill, Cheshunt, and at Room 204 County Hall.

Objections to the proposal should be sent in writing stating the grounds on which they are made to me by 1st April 1977.
