HYNDBURN BOROUGH COUNCIL

The Borough of Hyndburn (No. 38) Smoke Control Order 1977

The authorised fuels include anthracite, coke and other carbonised fuels, gas and electricity.

If confirmed, the Order will not come into operation before 1st November 1978, or before such later date as may be determined by the Secretary of State for the Environment.

SCHEDULE

The Borough of Hyndburn (No. 38) Smoke Control Order 1977

The area comprises the remaining part of Accrington not affected by Smoke Control Orders.

The boundary as shown on the map can be described as follows:

In the west it follows the centre line of the former Accrington-Bury railway in a southerly direction. From this line it turns due east along the projected southern boundary of number 169 Belfield Road. It turns north-east boundary of number 169 Belfield Road. It turns north-east and continues along the rear garden boundaries of Belfield Road to number 111 Belfield Road. It continues still in a north-easterly direction along the footpath, across Royds Street along the front of Eaton Bank to Rough Lee Road. It follows the centre line of Rough Lee Road north-east, then it turns east along the southern boundary of Holly Bank to Hollins Lane. It then continues north generally along the centre line of Hollins Lane, Manchester Road and Grange Lane and then east along Spring Gardens to Manchester Road. It briefly follows Manchester Road north before continuing east along the centre lines of Adelaide before continuing east along the centre lines of Adelaide Street and Sandy Lane to a point where it intersects with the extended centre line of Back Barnfield Street. It turns north along Back Barnfield Street to the rear of 32 Barnfield Street where it continues eastwards generally along the

rear boundaries of Ascot Way to Waddington Road. It follows the centre line of Waddington Road south to Sandy Lane, then west along the centre line of Sandy Lane for a Lane, then west along the centre line of Sandy Lane for a short distance to the extended eastern boundary of Broad Oak Hostel.
