

to stop up such rights as may exist on Road Used as Public Path (R.U.P.P.) No. 51 in the Parish of Hambledon which commences at the junction with Road U199 (east of Grove Copse) and runs in a north-north-westerly direction for 1,452 metres (1,587 yards) to its junction with R.U.P.P. No. 52.

A plan showing the proposals has been placed on deposit at the office of the Winchester City Council, City Offices, Colebrook Street, Winchester, at the Hambledon Post Office, Hambledon and at my office where they may be inspected free of charge during normal office hours.

On the hearing of the application, any person to whom notice is required to be given under paragraph 1 of the 12th Schedule to the Highways Act, 1959, any person who uses the R.U.P.P.s and any other person who would be aggrieved by the making of the Order applied for shall have the right to be heard.

*The Hampshire (New Forest District No. 4) (Parish of Netley Marsh—Parts of Footpaths Nos. 2 and 22) Public Path Diversion Order 1977.*

Notice is hereby given that on the 7th March 1977 the Hampshire County Council confirmed the above-named Order.

The effect of the Order as confirmed is to divert the public rights of way in the Parish of Netley Marsh described in the First Part of the Schedule hereto to the routes described in the Second Part.

Copies of the confirmed Order and map contained in it have been deposited at the office of the District Secretary, New Forest District Council, Appletree Court, Lyndhurst, and at the office of the undersigned, where they may be inspected free of charge during the normal office hours.

#### SCHEDULE

##### Part I

##### Description of Site of Existing Paths

Those parts of Footpaths Nos. 2 and 22 as described below.

##### (a) Netley Marsh Footpath No. 2

That part of Footpath No. 2 which commences at the junction with Footpath No. 22 and runs in an easterly direction for 230 metres (252 yards).

##### (b) Netley Marsh Footpath No. 22

That part of Footpath No. 22 which commences at the junction with Whitemoor Lane (C.129) and runs in an east-south-easterly direction for 148 metres (162 yards).

##### Part II

##### Description of Sites of Alternative Highways

##### (a) Netley Marsh Footpath No. 2

A 1.8 metre (6 feet) wide grass headland path which commences at the eastern end of the path described in Part I (a) of this Schedule and runs in a north-westerly direction for 116 metres (126 yards).

##### (b) Netley Marsh Footpath No. 22

A 1.2 metre (4 feet) wide earth woodland path which commences at the western end of the path as described in

Part I (b) of this Schedule and runs in a south-south-easterly direction parallel with Whitemoor Lane for 110 metres (120 yards) to join Footpath No. 21. (530)

##### PART I

##### Description of Site of Existing Path

Footpath No. 38 at Crondall which commences at the junction with Road C46 at Triggs Farm and runs in a south-westerly direction for 576 metres (630 yards) to Road C8.

##### PART II

##### Description of Site of Alternative Highway

A 1.8 metre wide enclosed grass path which commences at a stile at the junction with Road C46 at a point 102 metres (111 yards) south of the existing path, and runs in a south-westerly direction for 262 metres (287 yards) to a stile on the north side of Road A287 then recommencing at a stile on the south side of Road A287 and continuing south-westwards on the north side of Downlands Copse for 183 metres (200 yards) to a stile at the junction with Road C8.
