## WAGES COUNCIL

### EMPLOYMENT PROTECTION ACT 1975

#### *Flax and Hemp Wages Council (Great Britain)*

The Flax and Hemp Wages Council (Great Britain) hereby gives notice of proposals for (1) amending the provisions relating to statutory minimum remuneration set out in the Wages (Flax and Hemp) Order 1976 (Order FH(142)); and (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages Flax and Hemp (Holidays) Order 1976 (Order FH(143)).

The Wages Council intends that the revised provisions shall operate in 1977 only.
