#### GREATER MANCHESTER COUNTY COUNCIL

*The Greater Manchester County Council (Assheton Way and Oldham Road, Middleton) (Clearway) (Prohibition of Waiting) (County) Order 1975.*

Notice is hereby given that on the 15th March 1977 the Greater Manchester County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 6 to the Road Traffic Act 1974, the effect of which is:

- (a) To prohibit waiting, loading and unloading at all times on Assheton Way, Middleton, from Oldham Road to Long Street.
- (b) To prohibit waiting at all times and loading/unloading between 7.30 a.m. and 9.30 a.m. on Mondays to Saturdays and between 4 p.m. and 6.30 p.m. on Mondays to Fridays on Oldham Road, Middleton from Manchester New Road to Ashton Lane.

Exemption is included in the Order for the emergency services and for the purposes of work on or under the lengths of road.

*The Greater Manchester County Council (Unnamed Rear Access Road, Stanley Buildings, Bury) (Restriction of Waiting) (County) Order 1976.*

Notice is hereby given that on 8th March 1977 the Greater Manchester County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972, and Schedule 6 to the Road Traffic Act 1974 the effect of which is to prohibit waiting between the hours of 8 a.m. and 6 p.m. on Mondays to Fridays on the access road in the south side of Broad Street, Bury at the rear of Stanley Buildings.

The Order contains exemptions to permit waiting for the purposes of boarding or alighting, loading or unloading, the removal of furniture, funerals, building operations or work on or under the lengths of road. In addition, disabled persons' vehicles bearing a disabled person's badge and a parking disc will be able to wait for periods of up to 2 hours, return prohibited within 1 hour.

*The Greater Manchester County (The City of Salford (Area South of Chapel Street) (No Waiting) Order 1966) (Amendment) (County) Order 1977.*

Notice is hereby given that the Greater Manchester County Council propose to make an Order under sections 1 and 84D of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which will be to revoke the City of Salford (Area South of Chapel Street) (No Waiting) Order 1966 in so far as it prohibits waiting between 7.30 a.m. and 6.30 p.m. on Mondays to Saturdays on both sides of Brown Street, from Chapel Street for a distance of 10 yards in a southerly direction. The existing waiting restriction on this length of road between 8 a.m. and 6 p.m. on Mondays to Saturdays will remain.

#### NORTHAMPTONSHIRE COUNTY COUNCIL

*The Northamptonshire County Council (Windmill Road and Glassbrook Road, Rushden) (Prohibition of Waiting) Order.*

Notice is hereby given that on the 10th March 1977, the Northamptonshire County Council made an Order under sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, the effect of which is to prohibit the waiting of vehicles at all times on the lengths of road specified in the Schedule to this notice. (On the length of Windmill Road to be restricted waiting is at present prohibited only between the hours of 4 p.m. and midnight.)
