

WARWICKSHIRE COUNTY COUNCIL
ROAD TRAFFIC REGULATION ACT 1967
AS AMENDED

The Warwickshire County Council (Tachbrook/Heathcote Road, Whitnash) (Prohibition of Waiting and Driving) Order, 1977.

Notice is hereby given that on the 17th March 1977, the Warwickshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit the waiting of vehicles (except upon the direction or with the permission of a police constable in uniform or of a traffic warden) at all times on the lengths of road mentioned in Schedule 1 to this notice and also close to traffic that length of road specified in Schedule 2.

The Order will come into force on Monday 21st March 1977.

Exceptions will permit waiting for the purposes of picking up and setting down of passengers, loading and unloading of goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the Order together with a map showing the lengths of road affected may be inspected at the Office of the County Secretary, Shire Hall, Warwick, on Mondays to Fridays, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the 17th March 1977 apply to the High Court for this purpose.

SCHEDULE

1. *Prohibition of Waiting at any Time*
Tachbrook Road/Heathcote Road (including Service road) Whitnash
 - (i) *Tachbrook Road (A.452)*. Both sides, from a point 95.0 metres south of the projection of the centre line of Heathcote Road, northwards for a distance of 200.0 metres.
 - (ii) *Heathcote Road*. Both sides, from a point 75.0 metres west of the centre line of the Tachbrook Road, eastwards for a distance of 150.0 metres.
 - (iii) *Service Road*. Both sides from a point 10.0 metres north of its junction with Heathcote Road in a north-westerly direction for a distance of 70.0 metres including the turning bay.
2. *Prohibition of Vehicles.*
Service Road
From its junction with Heathcote Road northwards for a distance of 10 metres.

The Warwickshire County Council (School Lane and Rosemary Hill, Kenilworth) (Prohibition of Waiting) Order, 1977.

Notice is hereby given that on the 17th March 1977, the Warwickshire County Council made an Order under section 1 of the Road Traffic Regulation Act 1967, as amended, the effect of which is to prohibit the waiting of vehicles (except upon the direction or with the permission of a police constable in uniform or a traffic warden) at all times on the lengths of road specified in the Schedule to this notice.

The Order will come into force on Monday, 21st March 1977.

Exceptions will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the Order, together with a map showing the lengths of road affected, may be inspected at the County

Secretary's Department, Shire Hall, Warwick, on Mondays to Fridays inclusive, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or on the grounds that any requirement of that Act or any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the 17th March 1977 apply to the High Court for this purpose.

SCHEDULE

1. *School Lane*. Both sides, from its junction with Bridge Street, north-eastwards for a distance of 55.0 metres.
2. *Rosemary Hill*. North-east side, from its junction with School Lane for 38.0 metres in a south-easterly direction.

PROHIBITION OF WAITING, DALE STREET, GROVE STREET
AND REGENT STREET, LEAMINGTON SPA

The Borough of Royal Leamington Spa (Central Area) Traffic Regulation and Prohibition and Restriction of Waiting (Variation No. 2) Order, 1977.

Notice is hereby given that on the 17th March 1977, the Warwickshire County Council made an Order under sections 1 and 84D(1) of the Road Traffic Regulation Act, 1967, as amended, the effect of which is to prohibit the waiting of vehicles at all times (except upon the direction or with the permission of a police constable in uniform or of a traffic warden) in Dale Street, Grove Street and Regent Street, Leamington Spa as mentioned in the Schedule to this notice.

The Order will come into force on Monday, the 21st March 1977.

Exceptions will permit waiting for the purposes of picking up and setting down passengers, loading and unloading goods, for vehicles displaying a disabled person's badge and in connection with the maintenance of the road and the supply of gas, water or electricity.

A copy of the Order and of an Order already made under the said Act which is affected by the proposals, together with maps showing the lengths of road affected may be inspected at the County Secretary's Department, Shire Hall, Warwick on Mondays to Fridays inclusive, during normal office hours.

Any person who desires to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, may within 6 weeks from the 17th March 1977, apply to the High Court for this purpose.

SCHEDULE

Waiting to be prohibited at all times

1. *Dale Street*, east side, from a point 45.5 metres north of its junction with Regent Street (end of existing prohibition), northwards for 10 metres.
2. *Grove Street*, both sides, for a distance of 20 metres north and 20 metres south of the centre line of Regent Street.
3. *Regent Street*, both sides, from the end of the existing prohibition between Dale Street and Grove Street, to its junction with New Brook Street.
