- (d) To provide for the car parks listed in (a) to be operated by a "pay and display" system whereby the driver purchases a ticket for the period of parking required from an automatic machine and displays the ticket in a conspicuous position on the vehicle.

- (e) To fix the charge for the Riverside Car Park as follows:

All Days from 1st March to 30th October (depending on weather conditions) 8 a.m. to dusk—25p for 4 hours.

- (f) To provide for a 2 hour time restriction on the Castle Street Car Park in Wallingford without charge between the hours of 8 a.m. and 6 p.m. Mondays to Saturdays.

- (g) To empower the Council to levy an excess charge of £6 on any person who fails to display a ticket indicating a charge has been paid or whose vehicle is parked beyond the period for which an initial charge has been paid.

Princess Street

- To revoke the One Way Traffic Order and make the street two-way traffic flow.
- Prohibit vehicles from entering Princess Street from Singleton Street.
- Prohibit vehicles from entering Princess Street from Clarence Street unless requiring access to land or premises in Princess Street.
- Revoke the Waiting Restrictions in Princess Street and make the following restrictions instead:

EAST SIDE

"No Waiting, No Loading/Unloading at any time" from the southern kerb line of Singleton Street for a distance of approximately 45 metres in a southerly direction, and from the northern kerb line of Clarence Street for a distance of approximately 5 metres in a northerly direction.

EAST SIDE

"No Waiting at any time" to commence from a point 45 metres approximately south of the southern kerb line of Singleton Street for a distance of 100 metres approximately in a southern direction.

WEST SIDE

"No Waiting, No Loading/Unloading at any time" from the southern kerb line of Singleton Street for a distance of 5 metres approximately in a southerly direction and from the northern kerb line of Clarence Street for a distance of 5 metres approximately in a northerly direction.

WEST SIDE

"No Waiting at any time" from a point 5 metres approximately south of the southern kerb line of Singleton Street for a distance of 55 metres approximately in a southern direction; from a point 95 metres approximately south of the southern kerb line of Singleton Street for a distance of 10 metres approximately in a southern direction and from a point 140 metres approximately south of the southern kerb line of Singleton Street for a distance of 8 metres approximately in a southern direction.

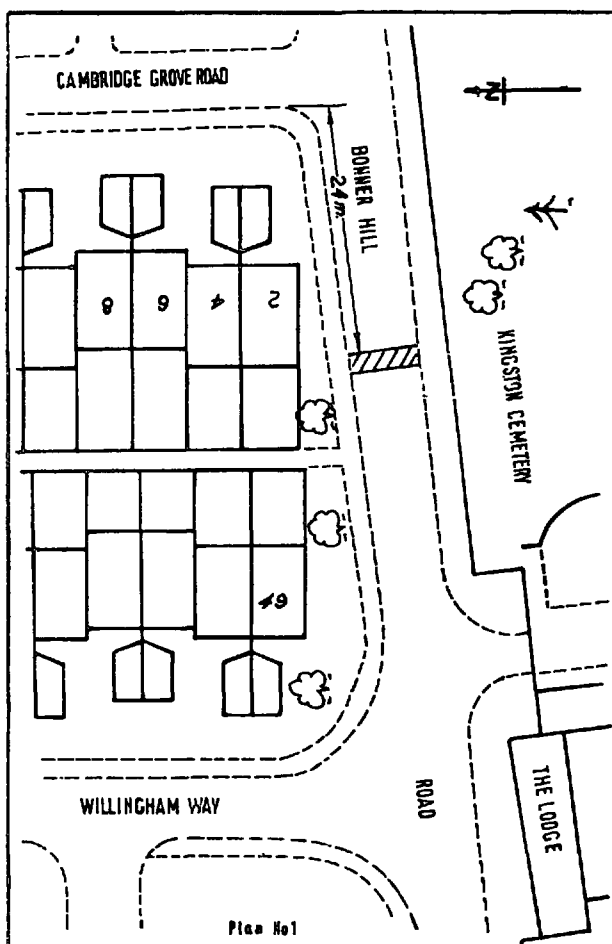
