West Glamorgan County Council (Bryn-y-Don Road, Mayhill, Swansea) (Prohibition of Driving) Order, 1977

Notice is hereby given that the West Glamorgan County Council propose to make an Order in exercise of their powers under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act, 1968 and Schedule 19 to the Local Government Act, 1972, the effect of which will be to prohibit vehicles from being driven in that length of Bryn-y-Don Road between two points

- (a) at its junction with Baptist Well Place and
- (b) at a point in line with the northern boundary of No. 6 Bryn-y-Don Road.

The road will be closed with appropriate barriers at these locations.

WEST GLAMORGAN COUNTY COUNCIL

West Glamorgan County Council (Various Streets, Aberavon) (Prohibition of Waiting) Order, 1977

Notice is hereby given that the West Glamorgan County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 of the Road Traffic Act 1974, the effect of which will be to prohibit waiting at all times on the undermentioned lengths or sides of roads:

Scarlet Avenue and Purcell Avenue (both sides), from a point in line with the western kerb line of Golden Avenue to a point 8 metres in a north-easterly direction from the northern kerb line of Elgar Avenue a distance of approximately 640 metres.

Scarlet Avenue Service Road (both sides), from a point in line with the eastern kerb line of Scarlet Avenue at the northern access point to a point in line with the eastern kerb line of Scarlet Avenue at the southern access point.

Strauss Road (both sides), from a point in line with the eastern kerb line of Scarlet Avenue to a point 8 metres north-east of the eastern kerb line of Auburn Avenue a distance of approximately 84 metres.

Tir Morfa Road (both sides), from a point in line with the eastern kerb line of Golden Avenue to a point in line with the north-western kerb line of Pier Way a distance of approximately 488 metres.

Pier Way (both sides), from a point 30 metres east of the eastern kerb line of Ocean Way to the end of the existing traffic order which terminates 10 metres east of the eastern kerb line of Princess Margaret Way a distance of 152 metres.

Ocean Way (both sides), from a point in line with the southern kerb line of Pier Way to a point in line with the northern kerb line of Marine Drive a distance of 174 metres approximately.

Marine Drive (both sides), from a point 8 metres east of the eastern kerb line of Ocean Way to the existing traffic order which terminates 6 metres east of the

eastern kerb line of Princess Margaret Way a distance of 88 metres approximately.

Golden Avenue (both sides), from a point 8 metres north of the eastern kerb line of Auburn Avenue to the existing traffic orders which terminate at the north-western end of Princess Margaret Way a distance of 70 metres approximately.

Auburn Avenue (both sides)—(north-west end), from a point in line with the south-eastern kerb line of Strauss Road for a distance of 8 metres in a south-easterly direction.

Auburn Avenue (both sides)—(south-east end), from a point in line with the western kerb line of Golden Avenue to a point 14 metres in a north-westerly direction.

Elgar Avenue, from a point in line with the southern kerb line of Purcell Avenue for a distance of 8 metres in a south-easterly direction.

Exemptions will be provided on the Order for essential services, loading and unloading facilities etc.
