SOMERSET COUNTY COUNCIL

*Somerset (Various Roads at Stoke St. Michael)
(Weight Restriction) (No. 1) Order 1977*

Notice is hereby given that on the 18th March 1977, the Somerset County Council made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended the effect of which is to prohibit any vehicle the weight of which whether laden or unladen exceeds 3 tons from proceeding in the roads in the Parish of Stoke St. Michael specified in the Schedule hereto, except for access to premises etc.

The Order will come into operation on the 28th March 1977.

Exemptions in the Order allow for access to land or premises, for maintenance of the roads or services, and by emergency vehicles.

A copy of the Order and a plan showing the roads affected may be inspected at County Hall, Taunton, or at the Post Office, Stoke St. Michael, during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the 18th March 1977, apply to the High Court for this purpose.
