## ROAD TRAFFIC ACTS

## BLAENAU GWENT BOROUGH COUNCIL

*Borough of Blaenau Gwent (St. Lukes Road, Tredegar)  
(Prohibition of Waiting) Order 1977*

- (f) the pursuance of statutory powers or duties;
- (g) a funeral, and
- (h) exempting vehicles of disabled persons.
