ANCIENT MONUMENTS ACTS 1913 TO 1953

The Motte West of Yockleton Hall Preservation Order 1977

Notice is hereby given that the Secretary of State for the Environment in exercise of the powers conferred by section 11 of the Historic Buildings and Ancient Monuments Act 1953 and now vested in him, has, on 25th March 1977, made an Order with the above title, placing under his more lasting protection the ancient monument known as Motte West of Yockleton Hall in the parish of Westbury in the county of Shropshire, in respect of which an interim preservation notice served under section 10 of the said Act was in force.
