## PRICES AND CONSUMER PROTECTION

### COUNTER-INFLATION ACT 1973

(1973 c. 9)

#### NOTICE

(under section 6(2) and (3))

To: Stewart Plastics Ltd.,  
1 Broad Street Place,  
London, EC2M 7EN.

The Price Commission, in exercise of their powers under section 6(2) and (3) of the Counter-Inflation Act 1973, hereby give you notice requiring you to restrict prices for the sale of goods in the course of business.

The said restriction requires you to reduce prices for the sale of goods (including plastic products for domestic, horticultural and industrial purposes) by an average of 10 per cent. until you have eliminated the excess over your reference level which arose in the period beginning on 30th April 1973 and ending on 30th April 1976, the said excess being an amount of £534,000.
