WAGES COUNCIL ACT 1959

Notice of intention to make an order abolishing the Retail Bespoke Tailoring Wages Council (England and Wales) and the Retail Bespoke Tailoring Wages Council (Scotland) and to establish the Retail Bespoke Tailoring Wages Council (Great Britain)

The Secretary of State for Employment in accordance with Schedule 1 of the Wages Council Act 1959, as amended by the Employment Protection Act, 1975, hereby gives notice that he intends, pursuant to the powers conferred upon him by subsections (1) and (3) of section 4 of the 1959 Act, to make an Order abolishing the Retail Bespoke Tailoring Wages Council (England and Wales) and the Retail Bespoke Wages Council (Scotland) and establishing a Retail Bespoke Tailoring Wages Council (Great Britain).
