- 4 The waiting restrictions which at present apply in the pedestrian priority area are to be continued in force.
- 5 Exceptions will be permitted for emergency vehicles, statutory undertakers' vehicles, funeral processions, invalid vehicles and, to facilitate the servicing of business premises, goods vehicles for the loading and unloading of goods. Public service vehicles (including school and works buses) will be permitted to use Princes Street (that portion closed to other traffic between King Street and Cornhill), Westgate Street and the Cornhill.

Vehicles displaying a disabled person's orange badge will be permitted to enter any of the roads mentioned at (3) above if the vehicle is a disabled person's vehicle intending

Licensed hackney carriages will be permitted to use the Buttermarket, St. Stephen's Lane (part) and Market Lane (part) but will not be permitted to use any of the other roads mentioned at (3) above.
