Notice is hereby given that by an Order made on Monday the 7th day of February 1977 upon the petition of the above named G. F. Scovell (Fruit Farms) Limited (hereinafter called the company) and of Richard George Dawson of King's Farm, Pebmarch, near Halstead in the County of Essex a member and director of the company on the 30th December 1976 preferred unto this Court

And upon hearing counsel for the petitioners for the Registrar of Companies (the respondent) and for Mary B. Dawson a director of the company

And upon reading the said petition the affidavit of Catherine Anne Dawson and the affidavit of Peter Harrop both filed the 20th January 1977 the affidavit of Richard George Dawson filed the 25th January 1977 and the exhibits in the said affidavits or some of them respectively referred to

And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of Peter Harrop and the exhibit thereto

And the petitioner the said Richard George Dawson and Mary B. Dawson by their counsel respectively undertaking that in connection with debts in respect of which at the 3rd February 1977 they are creditors of the company they shall use their best endeavours to procure that the company shall not make any payment in or towards satisfaction of such debts or any of them at any time when there shall for the time being be one or more other debts of the company remaining unpaid 28 days or more after falling due, that in any winding up scheme of arrangement or compromise with creditors after the said the 3rd February 1977 such debts or the balance thereof for the time being outstanding shall be postponed to all debts of the company arising contracted or incurred after the said the 3rd February 1977 and that a note of the said undertakings above should be affixed to or endorsed in the book of minutes of directors meetings kept by the company.

And the petitioners by their counsel undertaking within one month of the restoration of the name of the company to the register of companies to forward to the Registrar of Companies as required by sections 124 and 126 of the above mentioned Act, a copy of the annual return of the company for each of the years 1975 and 1976 together with the documents annexed thereto as required by section 127 of the said Act and to send to the Registrar of Companies as required by section 200 of the said Act a notification of any change among the directors of the company or in its secretary or in any of the particulars contained in its register of directors and secretaries, specifying the date of the change

This Court doth order that the name of the above named G. F. Scovell (Fruit Farms) Limited be restored to the register of companies

And it is ordered that an office copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said G. F. Scovell (Fruit Farms) Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off

And it is ordered that the Registrar of Companies do advertise this Order in his official name in the *London Gazette*

And it is ordered that the petitioners the said G. F. Scovell (Fruit Farms) Limited and Richard George Dawson do pay to the Registrar of Companies his costs of the said petition such costs to be taxed on the Common Fund basis.
