Notice is hereby given that by an order made on Monday, the 24th day of January 1977 upon the petition of the abovenamed Lampoon Music Limited (hereinafter called the company) and of Michael Andrew Paul Dolan and James Patrick Dawson both of 35 Horner Street London W.1 members of the company on the 17th November 1976 preferred unto this Court

And upon hearing counsel for the petitioners and for the Registrar of Companies (the respondent)

And upon reading the said petition the affidavit of Michael Andrew Paul Dolan and the affidavit of Enid Lucia Nogué both filed the 20th January 1977 and the exhibits in the said affidavits respectively referred to

And there being no opposition on behalf of Her Majesty to the relief sought by the said petition as appears from the said affidavit of Enid Lucia Nogué and the exhibit thereto

And the petitioners by their counsel undertaking within one month of the restoration of the name of the company to the register of companies to forward to the Registrar of Companies as required by sections 124 and 126 of the above-mentioned Act, a copy of the annual return of the company for each of the years 1972 to 1975 inclusive together with the documents annexed thereto as required by section 127 of the said Act, to give to the Registrar of Companies as required by section 107 of the said Act notice of any change in the situation of the registered office of the company, and to send to the Registrar of Companies as required by section 200 of the said Act a notification of any change among the directors of the company or in its secretary or in any of the particulars contained in its register of directors and secretaries specifying the date of such change

This Court doth order that the name of the above named Lampoon Music Limited be restored to the register of companies

And it is ordered that an office copy of this order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the said Lampoon Music Limited is thereupon to be deemed to have continued in existence as if its name had not been struck off
