Coast Protection Works—West Bay to Epple Bay Birchington

Notice is hereby given that, in accordance with Section 5, of the above mentioned Act, the Thanet District Council intend to carry out coast protection works between West Bay and Epple Bay Birchington, Kent. These works comprise

ROAD TRAFFIC REGULATION ACT 1967

*Derby City Council (Princes Street Area)
(Restriction of Waiting) Order 1977*

Notice is hereby given that Derby City Council pursuant to an arrangement made under Section 101 of the Local Government Act 1972 with Derbyshire County Council, in exercise of the powers of the said County Council under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended, made an Order on 22nd June 1977.

- (e) the laying and maintenance of Post Office cables
- (f) use in the service of a local authority in pursuance of statutory powers and duties
- (g) use in times of emergency
- (h) use for the delivery or collection of postal packets

The exemptions for disabled persons contained in L.A.T.O. (Exemptions for Disabled Persons) (England and Wales) Regulations 1971 as amended by 1975 Regulations are included in this Order.

A copy of the Order and the map showing the lengths of street affected may be examined at the City Secretary's department, Council House, Corporation Street, Derby during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972, or on the grounds that any requirements of the Acts or of any instrument made under it have not been complied with in relation to the Order, you may within 6 weeks from 22nd June 1977 apply to the High Court for this purpose.—Dated 4th July 1977.
