TYNE AND WEAR COUNTY COUNCIL

Tyne and Wear County Council (Eastbound Slip Road onto Coast Road (A1058) Newcastle upon Tyne) Bus Stop Clearway Order 1977

Notice is hereby given that Tyne and Wear County Council propose to make an Order under Section 1 (1), (2), (3) and (3B) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The purpose of the Order is to prohibit vehicles, other than buses, from waiting between 7 a.m. and 7 p.m. on any day at any bus stop in that length of road as described in the Schedule to this Order, where the carriageway at that stop is marked (a) as a bus stop and (b) with a broad yellow line adjacent to the edge of the carriageway ("the authorised markings").

While the Order remains in force it enables the Council at any time to lay or remove the authorised markings at or from any bus stop in a specified road or to adjust the position in that road of the authorised markings as traffic conditions may require.

Other vehicles would be permitted to wait at bus stops with authorised markings, where necessary:

- (a) for the removal of an obstruction to traffic;
- (b) in certain circumstances in exercise of statutory powers;
- (c) in certain emergencies; and
- (d) for police, fire brigade and ambulance purposes.

Exemptions—as in (a) above.

- (c) *The Greater Manchester County (Oak Street, Shaw, General Improvement Area) (Traffic Regulation) (No. 2) (Borough) Order 1977.*

- (i) to prohibit the driving of vehicles in

Park Street—from a point 9 metres south-west of Travis Street for 42 metres in a south-westerly direction
Travis Street—from a point 8 metres north-west of Park Street for 5 metres in a north-westerly direction
Crossley Street—from Greaves Street for 3 metres in a westerly direction
Gordon Street—from a point 5 metres east of Greaves Street for 4 metres in an easterly direction
Buckley Street—from a point 8 metres north of Chancery Lane for 13 metres in a northerly direction

Exemptions—for emergency service vehicles, highway works and works on statutory undertakers' equipment.

NORTH YORKSHIRE COUNTY COUNCIL

*The Council of the County of North Yorkshire
(Scarborough Town Centre) Traffic Regulation Order 1977*

Notice is hereby given that the North Yorkshire County Council propose to make an Order under Sections 1 (1), (2) and (3) and 84D (1) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The Order will make permanent the experimental traffic scheme at present operative in the Scarborough Town Centre and its effect will be as follows:

1. To prohibit the driving of motor vehicles and the pedalling of cycles in Bar Street and the section of Newborough which extends from St. Thomas Street to North Street.

Exceptions to this provision of the Order will be made for:

- (a) stage carriages;
- (b) goods vehicles conveying goods to or from premises in Bar Street;
- (c) goods vehicles conveying goods to or from premises on the affected section of Newborough (except between the hours of 11 am and 4 pm);
- (d) vehicles used for police, fire brigade or ambulance purposes;
- (e) vehicles engaged in building works and similar operations (subject to the prior written consent of the Scarborough Borough Council);
- (f) vehicles involved in the maintenance of essential services;
- (g) vehicles used by medical practitioners, nurses or midwives in connection with professional duties undertaken at premises on the affected roads;
- (h) vehicles proceeding to or from any garage or off-street parking place at premises on the affected roads.

2. To prohibit the waiting of vehicles (i) on the north side of Castle Road from James Place to the boundary between 52 and 54 Castle Road (ii) on the south side of Castle Road from Clarence Place to Sussex Street (iii) on the west side of St. Thomas Street from Waterhouse Lane for a distance of 78 metres in a northerly direction; and (iv) on the south-east side of Westborough from the boundary between 12 and 13 Westborough to Vernon Road.

Exceptions to this provision of the Order will be made so as to permit a vehicle to wait for as long as may be necessary:

- (a) to enable a person to board or alight;
- (b) to enable goods to be loaded or unloaded;
- (c) to enable it to be used in connection with building works, road works, emergency and essential services.

Also excepted, for limited periods, will be any vehicle in respect of which a disabled person's badge has been issued.

3. To prohibit vehicles proceeding in St. Nicholas Street from making a right-hand turn into Newborough. An exception to this provision of the Order will be made for mechanical road cleaning vehicles.
4. To prohibit the driving of vehicles in Huntriss Row other than in a north-westerly direction. An exception to this provision of the Order will be made for mechanical road cleaning vehicles.
