BLAENAU GWENT BOROUGH COUNCIL

Borough of Blaenau Gwent (Intermediate Road, Brynmawr) (Prohibition of Waiting) Order, 1977

Notice is hereby given that on the 14th July 1977 the Blaenau Gwent Borough Council, acting on behalf of the Gwent County Council in pursuance of arrangements made under section 101 of the Local Government Act 1972 and in exercise of the Gwent County Council's powers under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 of the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, made the above-named Order. above-named Order.

The Order will come into operation on 15th August 1977. When this Order comes into effect vehicles may not wait between the hours of 8 a.m. and 6 p.m. on Mondays to Fridays on the lengths of road specified in the Schedule hereto.

Exceptions are included in the Order to permit waiting for the purposes of picking up and setting down passengers: loading or unloading goods; delivery or collection of postal

packets; the maintenance of the road; the supply of gas, water and electricity and of any telegraphic line; the pursuance of statutory powers or duties; and exempts vehicles of disabled persons.

A copy of the Order and a map showing the lengths of road to which it refers may be inspected at Room 38 of my Department at the Municipal Offices, Civic Centre, Ebbw Vale, Gwent, or alternatively, at the Council Offices, Trafal-

gar House, Brynmawr, Gwent during normal office hours.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended as aforesaid, or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 14th July 1977 apply to the High Court for this purpose.
