Newport Street from its junction with Station Street to its junction with High Street to be one-way west to east.

Star Street from its junction with George Street to its junction with High Street to be one-way east to west.

Victoria Street from its junction with Garfield Road to its junction with John Street to be one-way north to

Garfield Road from its junction with West Street to its junction with Victoria Street to be one-way west

(b) To impose two-way traffic flow in John Street from its junction with High Street to its junction with Victoria Street.

The restrictions are required in connection with the pedestrian (service only) precinct in High Street and Angle-

sea Street, Ryde.

## LUTON BOROUGH COUNCIL

The Borough of Luton (Central Area) (Street Parking Places) and (Prohibition and Restriction of Waiting) Orders 1977.

Notice is hereby given that the Luton Borough Council, with the approval of the Bedfordshire County Council, propose to revoke the Order made in 1964 (and subsequent Amend-

ment Orders) which established the parking meter zone in the central area of Luton. In place of parking meters it is proposed in the above-named new Orders to authorise the use of parts of the roads named in the Schedule to this notice as free parking places for motor vehicles between 8 a.m. and 6 p.m., Monday to Saturday (between 8 a.m. and 8 p.m. in the Head Post Office service road in Dupathle Post) Dunstable Road).

Those parts of roads in the existing meter zone which will not be included in the proposed street parking places will be subject to restrictions on waiting similar to those currently applying in the meter zone, but with some variations. Not all the lengths of road at present occupied by parking meter bays will become free parking places; in some cases meters will be removed and the lengths of road involved will be subject to waiting restrictions.

In parts of the following roads, parking places will be

provided for motor cycles:

Cardigan Street, George Street West, Gordon Street, Hastings Street, King Street, Union Street, Victoria Street and Wellington Street.

Waiting for the purpose of enabling goods to be loaded on or unlocded from a vehicle will be permitted in restricted areas, except between the hours of 8 a.m. and 9.15 a.m. or between 4.30 p.m. and 6 p.m. in certain roads or parts of roads specified in the proposed Borough of Luton (Central Area) (Prohibition and Restriction of Waiting) Order 1977. In most cases the ban on loading or unloading during peak traffic hours has been in operation for many years and in this respect the present proposals are a consolidating measure. In a few cases the new proposal replaces an existing 24-hour ban on loading or unloading.
