

(c) Hallam Street, between Gildea Street and New Cavendish Street, from south-east to north-west;

(iii) compel the left turn by vehicular traffic proceeding south-westward in Great Castle Street into Regent Street;

(B) To allow the right turn into Wells Street by vehicular traffic proceeding in a north-easterly direction in Mortimer Street, prohibited by the Camden and City of Westminster (Prescribed Routes) (No. 2) Traffic Order 1975.

3. The one-way workings referred to in paragraph 2 (A) (ii) above would not apply in respect of anything done with the permission or at the direction of a police constable in uniform.

4.
