Four recommendations for Council Regulations on the conclusion of Agreements in the form of Exchanges of Letters between the EEC, on the one hand, and Tunisia, Morocco, Algeria and Turkey, on the other hand, fixing the additional amount to be deducted from the levy on imports into the Community of untreated olive oil, originating in the above-mentioned countries, for the period 1st November 1977-31st October 1978.
