STAMP DUTIES

BATH CITY COUNCIL

The Bath City Council (No. 1) Smoke Control Order 1977
Notice is hereby given that the Bath City Council in exercise of the powers conferred upon them by Section 11 of the Clean Air Act 1956 made an Order on 2nd September 1977, entitled the Bath City Council (No. 1) Smoke Control Order 1977 declaring the area described in the Schedule hereto to be a Smoke Control Area which Order has been submitted to the Department of the Environment for confirmation.

Subject to the exemptions provided by the Order and by virtue of Section 11 (4) of the Act if, on any day after the Order has come into operation, smoke is emitted from a chimney of any building within the Smoke Control Area

the occupier of that building shall be guilty of an offence and liable to a fine not exceeding £100 unless he proves that the emission of smoke was not caused by the use of any fuel other than an authorised fuel. The authorised fuel includes anthracite, coke and other carbonised fuels, electricity and gas.

If confirmed the Order will not come into operation before 1st December 1978, or before a later date determined by the Secretary of State for the Environment.
