 (ii) Dewsbury Terrace—for a distance of 37 metres from its junction with Priory Street.
 (iii) Priory Street—for a distance of 15 metres from its junction with Bicklegate and on its north-eastern side on the corner with Bishopshill Junior.
 (iv) Skeldergate—from its junction with Micklegate and Bridge Street to a point 80 metres north of its junction with Bishopsgate Street.
 - its junction with Bishopsgate Street.
 - (v) Trinity Lane.
- (c) No waiting between 08.00-18.00 hours on any day subject to the usual exemptions for disabled drivers, statutory undertakers, etc.

- (iii) Bishophill Senior/Cromwell Road-the whole of their north-eastern sides with the exception of two unrestricted lengths between the junctions with Skeldergate and Carr's Lane and Carr's Lane and Buckingham Street.

 (v) Priory Street—its north-east side with the exception of the lengths of 24 hour no-waiting referred to in paragraph (b) (iii) above and two lengths of 60 minute limited waiting.

Parking Places and Restriction of Waiting and Loading (Guildford) (Amendment) (No. 4) Order 1977

This change is being made so that vehicles loading and unloading goods for adjacent shops do not have to park on the main carriageway thereby obstructing traffic.

- 2. By extending the "No Waiting at Any Time" restric-tion on the south side of Castle Hill from a point opposite the western boundary of 3 Castle Hill to a point opposite the western boundary of 9 Castle Hill.
- 3. By removing the northernmost parking bay on the east side of Annandale Road and extending waiting restrictions between 8.30 a.m. and 6 p.m. along the section of road affected.

This amendment to the existing parking provision in Annandale Road is proposed in order to increase in Annanque Koad is proposed in order to increase road safety at the junction with Farnham Road. At present if the parking bay concerned is occupied, vehicles have to manouvre sharply to avoid the parked car. The replacement parking place originally proposed will not be provided, following objections from a local resident.
