MISUSE OF DRUGS ACT 1971, SECTION 12(4)

Cancellation of Direction Prohibiting Exercise of powers in relation to Controlled Drugs

In accordance with section 12(4) of the Misuse of Drugs Act 1971, notice is hereby given that on 21st October 1977, the Secretary of State gave the following direction which came into effect on 1st November 1977.

Whereas on 12th February 1974, a direction under section 12(2) of the Misuse of Drugs Act 1971 was given in respect of Sukumar Sarkar, M.B., B.S., a doctor, whose registered address is 46 Linnet Hill, Rochdale, Lancashire, prohibiting him from having in his possession, prescribing, administering, manufacturing, compounding and supplying and from authorising the administration and supply of the substances and products for the time being specified in Part I of Schedule 2 to that Act.

Now, therefore, in pursuance of section 12(3) of that Act I hereby cancel the said direction of 12th February 1974.

The Trunk Road (Four Crosses, Welshpool) (Prohibition of Waiting) Order, 1977

Notice is hereby given that the Secretary of State proposes to make an Order under section 17 of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, the effect of which will be to prohibit waiting in that length of road specified in the Schedule to this notice.

Exceptions will be provided in the Order to enable a vehicle to wait for so long as may be necessary for a person to board or alight from the vehicle, to enable goods to be loaded onto or unloaded from the vehicle, to enable the vehicle to be used in connection with any building operation or demolition, the removal of any obstruction of traffic, the maintenance of the road or the services therein, or to enable the vehicle to be used in the services of a local authority in pursuance of statutory powers or duties.

Exceptions will also be provided in the Order to allow vehicles bearing both a disabled person's badge and a parking disc to wait on the side of road specified in the Schedule to this notice, for a period not exceeding 2 hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle on the same side of road).

A copy of the proposed Order, together with a plan and statement of reasons for making the Order may be seen during normal office hours at the offices of the (1) Powys County Council, Powys County Hall, Llandrindod Wells, Powys, and (2) the Llandysilio Community Council, Park Side, Park View, Four Crosses, Llanymyech.

Objections to the proposed Order should be sent to the Secretary of State, Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff, CF4 SPL by 1st December 1977, quoting the reference number WR15/6100 and stating the grounds of objection.

And it is ordered that the Registrar of Companies do advertise this Order in his official name in the London Gazette

And it is ordered that the petitioners the said Industrial & Provincial Investments Limited and Gerald Reginald Evans do pay to the Registrar of Companies his costs of the said petition such costs to be taxed on the Common Fund basis
