SCHEDULR III

Pension Increases

For those currently entitled to recieve a Pension Increase who were discharged before 31st July 1973, the pension in issue may be increased by 26.1 per cent from 1st December 1975, by 13.8 per cent from 1st December 1976 and by 17.7 per cent from 1st December 1977, provided that:

- (a) the pensioner has attained the age of 55 years, or
- (b) the pension is a widow's pension, or
- (c) the pensioner was invalided from Naval service, or

(d) the pensioner is permanently incapacitated by physical or mental infirmity from engaging in regular full-time employment.
