TOWN AND COUNTRY PLANNING ACT 1971

That length of highway to be stopped up is at St. Mellons in the County of South Glamorgan and is that length of Vaindre Lane which extends from a point 660 yards east of its junction with Newport Road (A4161) in a general easterly direction to a point 777 yards east of the said junction, a distance of 117 yards.

SOUTHAMPTON CITY COUNCIL

City of Southampton (Back of the Walls and Gloucester Passage) (Prohibition of Driving) Order 1977

The effect of this Order will be to establish "no waiting at any time" across the closed end of Back of the Walls, and on both sides of Back of the Walls from its closed end southwards for a distance of 12 metres, and also to establish "no waiting 8 a.m. to 6 p.m. Monday to Saturday" on the east side of Back of the Walls from a point 12 metres south of its closed end southwards for a distance of 22 metres.

The Parking Places (Southampton) (First Controlled Zone) (Consolidation and Amendment) Order 1977

The effect of this Order will be as follows:

- (i) To remove the four parking meter bays on the east side of Back of the Walls in order to ensure full width for turning vehicles. These bays will be replaced by "no waiting 8 a.m. to 6 p.m. Monday to Saturday" as outlined above.
- (ii) The original Parking Places Order was made in 1967 and there have been 25 amendments since that date. This Order will rationalise the original Order and its amendments into one consolidated Order.
- (iii) This Order will also have the effect of increasing the excess charge, incurred when the initial waiting period has expired, from £2.00 to £5.00.

The Parking Places (Southampton) (Second Controlled Zone) (Amendment No. 1) Order 1977

The effect of this Order will be to increase the excess charge for the on-street car parking meters in the Second Controlled Zone from £2.00 to £5.00. This Excess Charge is

incurred when the normal initial parking time has expired.

DEVON COUNTY COUNCIL

The County of Devon (Various Road, St. Marychurch, Torquay) (Restriction and Limitation of Waiting) Order 1977

Exemptions in the Order permit waiting for the purposes of boarding and alighting, loading or unloading, Post Office services, maintenance of the road, supply of gas, water and electricity, pursuance of statutory powers or duties, taking in petrol, oil or air from a garage. The statutory exemptions for disabled persons' vehicles are included.
