NOTICE OF SEIZURE UNDER THE CUSTOMS
AND EXCISE ACT 1952

Pursuant to section 275(5) of the Customs and Excise Act 1952 and paragraph 1 of the 7th Schedule thereto, the Commissioners of Customs and Excise hereby give you notice that by virtue of the powers contained in the customs and excise Acts and enactments amending those Acts, certain goods, namely 600 cigarettes, one Olympus still camera with F1.8 lens, one Omzuiko 135 mm lens No. 138119 and one Omzuiko 24 mm lens No. 127848 detained at London (Heathrow) Airport on 15th August 1977 have been seized as liable to forfeiture upon the grounds that: the said goods being chargeable with duty and tax were not declared by the said Michael David Andrew Delaney as required by section 6 of the Finance Act 1968 when he entered the United Kingdom at London (Heathrow) Airport on 15th August 1977.

Whereby and by force of section 6(3) of the Finance Act 1968 the said goods are liable to forfeiture.

If you claim that the said goods are not liable to forfeiture you must within 1 month from the date of this notice of seizure give notice of your claim in accordance with the said Schedule to the said Act specifying the name and address of a Solicitor in England or Wales who is authorised to accept service of process and to act on your behalf. In default of such notice the said goods will be deemed to have been duly condemned as forfeited and will be liable to be disposed of in such manner as the Commissioners of Customs and Excise may direct. If you make such claim within the time aforesaid, legal proceedings will be taken for the condemnation thereof.
