The Trunk Road (Pont Abraham, Dyfed) (One-way Traffic) Order 1977

Notice is hereby given that the Secretary of State for Wales has made an Order under section 1 of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968 and Schedule 6 to the Road Traffic Act 1974, which shall come into operation on 31st December 1977.

The effect of the Order will be that no person shall cause any vehicle to proceed in the western carriageway of that length of trunk road specified in the Schedule to this notice in other than a general northerly direction.

The Order also revokes the Trunk Road (Pont Abraham, Dyfed) (Temporary One-Way Traffic) Order 1976.

A copy of the Order, together with a plan and a statement of reasons for making the Order, may be seen during normal office hours at the offices of the Llanelli Borough Council, Town Hall, Llanelli during a period of six weeks from 16th December 1977.

Copies of the Order may be obtained, free of charge, on application to the Secretary of State, Welsh Office, Transport and Highways Group, Government Buildings, Ty Glas Road, Llanishen, Cardiff CF4 5PL, quoting the reference WR15/2/84.

If you wish to question the validity of the Order or of any provision contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, or that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within the aforesaid period of 6 weeks apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

SCHEDULE

That length of the London-Fishguard Trunk Road (A.48) near Pont Abraham in the County of Dyfed which extends from a point 145 yards south of the centreline of Castell Isaf Bridge in a general southerly direction for a distance of 875 yards.

The Wholesale Mantle and Costume Wages Council (Great Britain) hereby gives notice of proposals for (1) varying the statutory minimum remuneration set out in the Wages (Wholesale Mantle and Costume) (No. 2) Order 1976 (Order WM(99)); (2) amending the provisions relating to holidays and holiday remuneration set out in the Wages (Wholesale Mantle and Costume) (Holidays) Order 1976 (Order WM(100)); and (3) the revocation of Order WM(99) and Order WM(100).

The Wages Council intends that the revised provisions shall come into operation on 16th January 1978.
