**GATESHEAD METROPOLITAN BOROUGH COUNCIL**

*The Borough Council of Gateshead (Greenside Road, Crawcrook) (Prohibition of Waiting) Order 1977*

Notice is hereby given that on the 23rd January 1978, pursuant to arrangements made under section 101 of the Local Government Act 1972 with the County Council of Tyne and Wear the Borough Council of Gateshead made an Order under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

This Order which makes it unlawful to cause or permit any vehicle to wait on the Eastern side of Greenside Road, Crawcrook from its junction with Main Street, Crawcrook for a distance of 13.7 metres comes into operation on the 1st February 1978.

Exceptions are provided in the Order for vehicles to wait for so long as may be necessary for a person to board or alight, to enable goods to be loaded or unloaded, to enable a vehicle to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance of the road or services therein to enable a vehicle to be used in pursuance of statutory powers or duties and for a period of not more than two hours, users of cars displaying the disabled person's badge and parking disc.

A copy of the Order and a map showing the length of the restricted road may be examined at the office of the undersigned on Monday to Thursday between 8.45 a.m. and 5 p.m. and on Friday between 8.45 a.m. and 4.35 p.m.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order you may within 6 weeks from the 26th January 1978 apply to the High Court for this purpose.
