### BEDFORDSHIRE COUNTY COUNCIL

The County of Bedfordshire (Clipstone Road, Eggington)
(Width Restriction) Order 1978

Notice is hereby given that on the 23rd January 1978, the Bedfordshire County Council made the above-named Order in exercise of their powers under section 1 of the Road Traffic Regulations Act 1967, as amended by Part IX of the Transport Act 1968, and Schedule 19 to the Local Government Act 1972.

The effect of the Order will be to prohibit the driving of any vehicle the width of which, inclusive of any load on the vehicle, exceeds 6 feet 6 inches in the whole length of Clipstone Road, Eggington (Route UC 242), which runs from the Leighton Buzzard Road (Route A4012) to Mile Tree Road (Route UC 243). The Order will come into

effect on 6th February 1978.

The Order contains exemptions for vehicles conveying persons, goods or merchandise to or from any premises on or adjacent to Clipstone Road, and for vehicles used for the purposes of agriculture, mineral workings or forestry in connection with land adjacent to the road, or in connection with any building operation or demolition, the removal of any obstruction to traffic, or the maintenance, improvement or reconstruction of the road or the services therein.

Copies of the Order, together with maps showing the road concerned and alternative routes, may be inspected at the offices of the undersigned at County Hall, Bedford, during

normal office hours.

Any person who desires to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers conferred by the Road Traffic Regulation Act, 1967, as amended, or on the ground that any requirement of that Act or of any instrument made under has not been complied with in relation to the Order, may, within 6 weeks of the 23rd January 1978, apply to the High Court for that purpose.

(b) Restrict waiting between the hours of 8 a.m. and 6 p.m. on Mondays to Saturdays inclusive to 1 hour in any 2, on the lengths of road specified in Schedule 6 to this notice.
