The County of Dorset (Restricted Roads) (No. 2) Order 1978 Extension of Speed Restriction—Shaftesbury

Notice is hereby given that on 30th January 1978 the Dorset County Council made an Order under sections 72(3) and 73(1) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968 and Schedule 19 to the Local Government Act 1972.

When this Order comes into effect on 3rd February 1978 the length of road specified in the Schedule hereunder will become subject to a speed restriction of 30 m.p.h.

A copy of the Order and a plan showing the length of road affected are available for inspection during normal office hours Monday to Friday at Dorset County Council, Transportation and Engineering Department, County Hall, Dorchester, Dorset, and North Dorset District Council, Nordon, Salisbury Road, Blandford, Dorset.

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1967, as amended, or on the grounds that any requirement of that Act or of any instrument made under it, has not been complied with in relation to the Order, you may, within 6 weeks from the date hereunder apply to the High Court for this purpose.

That length of the B3091 in Shaftesbury, from its junction with St. James Street, south-westwards for a distance of approximately 130 metres.

The County of Durham (Hewitson Road, Darlington) (Prohibition of Driving) Order, 1978

Notice is hereby given that on the 2nd February 1978, the County Council of Durham made an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act

1967 as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974.

The effect of the Order which will come into operation on the 6th February 1978, will be to prohibit the driving of vehicles on that length of Hewitson Road in the Borough of Darlington in Durham County from its junction with Yarm Road for a distance of 5 yards in a southerly direction.

*Amended Notice**The County of Durham (Various Roads, Ferryhill) (Prohibition and Restriction of Waiting) Order*

Notice is hereby given that the Durham County Council propose to make an Order under section 1 (1), (2) and (3) of the Road Traffic Regulation Act 1967 as amended.

The effect of the Order will be to prohibit waiting by vehicles at any time on the sides of roads at Ferryhill in Sedgefield District described in the Schedule to this notice.

Exemptions in the Order will permit waiting for the purposes of:

- (a) picking up and setting down passengers ;
- (b) loading and unloading of goods ;
- (c) delivery and collection of postal packets ;
- (d) building operations, demolitions, removal of obstructions, maintenance of the roads ;
- (e) Police, Fire Brigade and ambulance vehicles ;
- (f) statutory powers ;
- (g) invalid carriages.
