(ii) to increase the excess charge to £2; and

(iii) to provide that only coins of the denominations of 5 new pence or 10 new pence may be used for the payment of either of those initial charges;

The charges, etc., referred to in this sub-paragraph will come into operation in respect of the parking places on the highways or parts of the highways specified in column 1 of Schedules 3 and 4 to this Notice on the date specified in relation thereto in column 2 of those Schedules;

(b) in respect of residents' parking places on the highways listed in Schedule 5 to this Notice:

) to increase the daily charge to 20p; and) to increase the charge for 3 monthly and 12 monthly season tickets to £7.50 and £27 respectively. The charges referred to in this sub-paragraph will come into operation on 1st June 1978.

3. The classes of vehicles for which the parking places (referred to in paragraph 2(B) above) will be available and the permitted hours for parking except as stated in that paragraph will remain unchanged.

4. The Order will come into operation in respect of the metered parking places on the highways specified in column 1 of Schedule 2 to this Notice on the date specified in relation thereto in column 6 of that Schedule.

5. A copy of the Order, of the City of Westminster (Parking Places) Order 1968 (and of the Orders which have previously amended or applied that Order) and of the map which indicates each road and length of road to which the Order relates can be inspected until the end of six weeks from the date on which the Order was made during normal office hours on Mondays to Fridays inclusive in Room B.21, The County Hall, London, SE1 7PB.

Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the powers of the relevant sections of the Road Traffic Regulation Act 1967 or on the ground that any requirement thereof or of section 84A, 84B or 84C of the Act or of any regulations made under the said section 84C has not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.
