WEST GLAMORGAN COUNTY COUNCIL

West Glamorgan County Council (Cory Street, Sketty, Swansea) (Prohibition of Waiting) Order 1978

(c) Loading/unloading restrictions

Bishopthorpe Road; Bishopgate Street; Blossom Street; Bridge Street; Church Street; Clifford Street; Colliergate; Coppergate; Davygate; Fawcett Street; Fishergate; Fossgate; George Hudson Street; Gillygate; Goodramgate; High Petergate; King's Square; Layerthorpe; Lendal; Lord Mayor's Walk; Low Ousegate; Monkgate; Museum Street; Nessgate; Nunbury Lane; Paragon Street; Parliament Street; Pavement; Prices Lane; Rougier Street; St. Maurice's Road; St. Sampsons Square; Scarcroft Road; The Stonebow; Tower Street; Walmgate.

Tyne and Wear County Council (Various Roads, Sunderland) (40 m.p.h. Speed Limit) Order 1978

40 miles per hour Speed Limit Revoked

- (i) (A183) *Chester Road*. That length of Chester Road (A183) in the County Borough of Sunderland which extends from the west side of its junction with Grindon Gardens in a westerly direction for a distance of 913 yards.
- (ii) (A19, A184) *Newcastle Road*. That length of the Newcastle Road (A19, A184) in the County Borough of Sunderland which extends from a point 116 yards north-west of its junction with Viewforth Terrace, in a north-westerly direction to a point 112 yards north-west of its junction with Shields Road, a distance of approximately 840 yards.

The Borough of Fareham (Bus Stops) (Clearway) Order 1978

3 The road mentioned in paragraph 2 above is:

- (i) West Street, Fareham between its junction with High Street and its junction with Quay Street
- (ii) West Street, Fareham between its junction with Portland Street and its junction with the West End roundabout.

4 Although the Order includes every bus stop in the road specified above, it should be noted that the provisions of the Order which prohibit waiting will apply only to those bus stops which the Council marks with the authorised markings.

5 While the Order remains in force it enables the Council at any time to lay or to remove the authorised markings at or from any bus stop in a specified road or to adjust the position in that road of the authorised markings, as traffic conditions may require.

6 Other vehicles will be permitted to wait at bus stops with authorised markings, where necessary:

- (a) for the removal of an obstruction to traffic;
- (b) in certain circumstances in exercise of statutory powers;
- (c) in certain emergencies; and
- (d) for police, fire brigade and ambulance purposes.

7 Details of these proposals are contained in the draft Order which, together with a map showing the full extent

of the road affected and a statement of the Council's reasons for proposing to make the Order, may be inspected at the offices of the undersigned during the usual office hours.
