

ELLESMERE PORT AND NESTON BOROUGH COUNCIL

The Borough of Ellesmere Port and Neston (Street Parking Places) Order, 1977

Notice is hereby given that the Ellesmere Port and Neston Borough Council have made an Order under sections 28(1), 31(1) and 84D of the Road Traffic Regulation Act, 1967 as amended by Part IX of the Transport Act 1968 Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974 and all other enabling powers. The Order entitled the Borough of Ellesmere Port and Neston (Street Parking Places) Order 1977 will come into force on the 20th February, 1978.

The effect of the Order will be to revoke the Borough of Ellesmere Port (Street Parking Places) Order 1974 and to authorise the roads and parts of roads specified in the Schedule hereto, to be used, subject to certain conditions, as street parking places. The Schedule also specifies the classes of vehicles, the days and hours of operation and the maximum waiting period in each case. Effectively the Order is in the same terms as the said 1974 Order (to be revoked) except that the Station Road cul-de-sac described in paragraph 14 to the Schedule is now included as an authorised parking place. No charge for parking will be made.

A copy of the Order and relevant map may be inspected at the offices of the undersigned during normal office hours.

Any person who desires to question the validity of the Order or any provision contained therein on the ground that it is not within the powers conferred by the Road Traffic Regulation Act 1967, amended as aforesaid, or on the ground that any requirement of that Act or any regulation made thereunder has not been complied with in relation to the Order, may within 6 weeks from the 31st January, 1978 make application for the purpose to the High Court.
