Notice is hereby given that the County Council of Avon propose to make the following Orders under sections 1 and 84D (1) and sections 28, 31 and 84D (1) of the Road Traffic Regulation Act, 1967, as amended:

1. County Council of Avon (City of Bath) (Central Area) (General Traffic Regulation) (Variation No. 8) Order 1978, the effect of which will be to amend further the City of Bath (Central Area) (General Traffic Regulation) Order 1968 so as-

(a) to institute one-way traffic working on the lengths of roads specified in Schedule 1 to this Notice; (b) to prohibit waiting by any vehicle (subject to specified exemptions) for the whole 24 hours of every day in the roads specified in Schedule 2 to this Notice;

day in the roads specified in Schedule 2 to this Notice;
(c) to withdraw exemptions, in the waiting prohibition, which permit loading or unloading of goods, persons to board or alight from vehicles, waiting by window cleaners', chimney sweeps' or bill posters' vehicles and waiting by disabled persons' vehicles on both sides of the main carriageway of Ambury for the whole twenty four hours of every day;
(d) to revoke the one-way traffic working in Pierrepont Place and Old Orchard Street and
(e) to omit references to certain roads closed.

2. County Council of Avon (City of Bath) (Central Area) (Street Parking Places) (Variation No. 9) Order 1978 the effect of which will be to amend further the City of Bath (Central Area) (Street Parking Places) Order 1968 so as to re-instate a street parking place on the south-west side of Grand Parade between 8 a.m. and 6 p.m. on normal weekdays with a time limit of twenty minutes.

The proposals are, in general, to make permanent the Experimental Orders currently in operation.

SCHEDULE 1

One-Way Traffic

Ambury, eastern side of the main carriageway, including the lay-by, from Broad Quay towards Corn Street.

Ambury, western side of the main carriageway, from Corn Street towards Green Park Road.

Avon Street, between its junction with Corn Street and its junction with Green Park Road, from Green Park Road towards Corn Street.

Broad Quay, from Dorchester Street or Southgate towards Green Park Road.

Corn Street, from Avon Street towards St. James's Parade.

Green Park Road, between its junction with Broad Quay and Avon Street, from Broad Quay towards Avon Street or the remaining length of Green Park Road.

Railway Street, from Newark Street towards Manvers Street.

St. James's Parade, between its junction with Corn Street and its junction with Southgate, from Corn Street or the remaining length of St. James's Parade towards Somerset Street or Southgate.

Southgate, from St. James's Parade or Somerset Street towards Dorchester Street or Broad Quay.

- 1. County Council of Avon (City of Bath) (Outer Areas) (General Traffic Regulation) (Variation No. 5) Order 1978, the effect of which will be to amend further the City of Bath (Outer Areas) (General Traffic Regulation) Order 1971 so as
 - (a) to withdraw exemptions, in the waiting prohibition, which permit loading and unloading of goods; waiting by window cleaners', chimney sweeps' or bill posters' vehicles and waiting by disabled persons' vehicles between 8 a.m. and 9.15 a.m. and between 4.15 p.m. and 6 p.m. in the lengths of road specified in Schedule 1 to this notice;

(b) to prohibit waiting by any vehicle (subject to specified exemptions) for the whole 24 hours of every day in lengths of St. Saviour's Road, Grosvenor Bridge Road and London Road;

(c) to prohibit waiting by any vehicle (subject to specified exemptions) between 8 a.m. and 6 p.m. on normal weekdays in a length of London Road—southeast side;

east side;
(d) to institute one-way traffic working in Grosvenor Place (between London Road and Ringswell Gardens) from Ringswell Gardens towards London Road. The alternative route will be via the central entrance into Grosvenor Place or Grosvenor Bridge Road and Ringswell Gardens;

(e) to make minor adjustments consequent upon the "no loading and unloading" prohibition.

- County Council of Avon (City of Bath) (Outer Areas) (Street Parking Places) (Variation No. 5) Order 1978, the effect of which will be to vary further the provisions of the City of Bath (Outer Areas) (Street Parking Places) Order 1971 so as to authorise the use of lengths of the north-west side of London Road as street parking places, free of charge between 8 a.m. and 6 p.m. on normal weekdays:
 - (a) at Kensington House, Mile End and Worcester Terrace with a time limit of two hours and
