

the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, and Schedule 19 of the Local Government Act 1972, and of all other powers them enabling in that behalf and after consultation with the Chief Officer of Police for Hampshire, the effect of which is to impose a 30 m.p.h. speed limit on the recently constructed length of road B.3334 Titchfield Road, Crofton, between its junction with Anker Lane and a point 335 yards north of that junction.

A copy of the Order and a copy of the plan showing the length of road in question, may be inspected at the office of the Borough Secretary, Fareham Borough Council, Civic Offices, High Street, Fareham and at the office of the undersigned during usual office hours.

The Order will come into operation on 15th February 1978.

Any person who desires to question the validity of the Order or of any provision contained in the Order on the grounds that it is not within the powers of sections 72, 73 and 74 of the Road Traffic Regulation Act, 1967, or on the grounds that any requirement of those sections or of section 84A, 84B or 84C of the Act or any regulation made under the said section 84C has not been complied with in relation to the Order may, within 6 weeks from the date that the Order was made, make application for the purpose to the High Court.

#### HEREFORD AND WORCESTER COUNTY COUNCIL

##### ROAD TRAFFIC REGULATION ACT 1967

*The County Council of Hereford and Worcester (Various Roads, Hereford) (Prohibition and Restriction of Waiting, Loading and Unloading) Order 1978.*

Notice is hereby given that the County Council of Hereford and Worcester propose to make an Order under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act, 1972 and Schedule 6 to the Road Traffic Act 1974, and of all other enabling powers.

The Orders will impose the following restrictions:

- (i) Prohibition of waiting at all times on the west side of Green Street, Hereford from its junction with St. James Road for a distance of 30 metres (32·81 yards) in a northerly direction;
- (ii) Restriction of waiting between the hours of 8 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive on the north-west side of Kyrle Street, Hereford from a point 21·03 metres (23 yards) from its junction with Union Walk for a distance of 25 metres (27·34 yards) in a south-westerly direction;
- (iii) Prohibit waiting, loading and unloading between the hours of 8.30 a.m. to 9.30 a.m. from Mondays to Saturdays inclusive on the south-east side of Commercial Road, Hereford from its junction with Bath Street, northwards for a distance of 99 metres (325 feet) in a northerly direction. (The southerly boundary of the Hop Pole Hotel).

Waiting by vehicles of the undermentioned classes or for the undermentioned purposes are exempt where appropriate from the provisions of this Order:

- (1) To enable persons to board or alight;
- (2) Vehicles in use by the Post Office;
- (3) To enable certain essential works to be carried out or in pursuance of statutory powers or duties;
- (4) Vehicles driven by physically disabled persons which display the badge issued under the Local Authority's Orange Badge scheme;
- (5) For the collection or delivery of furniture or effects;
- (6) Ceremonial vehicles used in connection with a funeral or marriage service;
- (7) To obtain certain services from a garage;
- (8) To enable goods to be loaded or unloaded from the vehicle.

A copy of the draft Order, together with map showing the sides of lengths of road affected and a statement of the Council's reasons for proposing to make the Order, may be examined at the Hereford City Council Offices, Town Hall

and at the Shirehall, Hereford from Monday to Friday between the hours of 9.30 a.m.-12.30 p.m. and 2 p.m.-4 p.m.

Objections to the proposal giving reasons must be sent in writing to the undersigned by 13th March 1978.

#### HEREFORD AND WORCESTER COUNTY COUNCIL

##### ROAD TRAFFIC REGULATION ACT 1967

*The County of Hereford and Worcester Various Road Traffic Regulation Orders, Redditch*

Notice is hereby given that on 3rd February 1978 the County Council of Hereford and Worcester have made the following Orders under section 1(1), (2) and (3) of the Road Traffic Regulation Act 1967, as amended by Part IX of the Transport Act 1968, Schedule 19 to the Local Government Act 1972 and Schedule 6 to the Road Traffic Act 1974, and of all other enabling powers:

- (1) *The County of Hereford and Worcester (Evesham Road, Headless Cross Drive and Coldfield Drive Junction, Redditch) (Box Junction) Order 1978*

This Order will introduce a yellow box marking at the junction of Evesham Road, Headless Cross Drive and Coldfield Drive. No vehicle shall be driven into the boxed area and thereafter driven in such a direction that it becomes necessary, owing to the presence of stationary vehicles, for any part of the vehicle to remain at rest within the box area, unless:—

1. the vehicle is intending to make a right-hand turn and is prevented from doing so only by the presence of stationary vehicles;
2. the vehicle is in use for police, fire brigade or ambulance purposes;
3. the vehicle, the driver of which when entering the boxed area had reasonable cause to believe that he/she would immediately be able to drive the vehicle out of the area; and
4. the direction or permission of a police constable in uniform or of a traffic warden has been obtained.

- (2) *The County of Hereford and Worcester (The Slip Road between Birchfield Road and Headless Cross Drive, Redditch) (One-Way Traffic) Order 1978*

This Order will introduce a one-way system in the slip road between Birchfield Road and Headless Cross Drive, Redditch, so that all vehicles must travel in an easterly direction. Mechanical road cleansing vehicles are exempt from the provision of the Order.

- (3) *The County of Hereford and Worcester (Evesham Road, Headless Cross Drive, Birchfield Road and Coldfield Drive, Redditch) (Prohibition and Restriction of Waiting) Order 1978*

This Order will:—

(1) prohibit waiting by vehicles at all times on the following lengths of roads:—

- (a) A.441 Evesham Road, east side from the centre line of the junction with Coldfield Drive for a distance of 32 metres (105 ft.) in a northerly direction;
- (b) Coldfield Drive, both sides from its junction with Evesham Road for a distance of 15 metres (49 ft.) in an easterly direction;
- (c) Headless Cross Drive, north side between its junction with Evesham Road and Birchfield Road and south side from its junction with Evesham Road for a distance of 15 metres (49 ft.) in a westerly direction and from a point 90 metres (296 ft.) west of its junction with Evesham Road to its junction with Birchfield Road;
- (d) the slip road between Birchfield Road and Headless Cross Drive on both sides over the whole length;
- (e) A.448 Birchfield Road, north side from a point 20 metres (66 ft.) east of its junction with Headless Cross Drive for a distance of 98 metres (322 ft.) in a westerly direction.

(2) restrict waiting by vehicles for a limited period of one hour in any two hours on the south side of Headless Cross Drive from a point 15 metres (49 ft.) west of its junction with Evesham Road for a distance of 75 metres (247 ft.) in a westerly direction.
